Sub: Prayer for lodging FIR against arrested accused persons named i) Goutam Pal (48 Yrs) S/o Aswini Pal of Vill Rajmadhabpur , P.S- Barjora, Dist- Bankura and ii) Bikash Mondal (32 yrs) S/o Matar Mondal of Vill Dubrajpur, PS Saltora, Dist Bankura under proper section of law.

Sir,

In producing herewith accused person named i) Goutam Pal (48 Yrs) S/o Aswini Pal of Vill Rajmadhabpur , P.S- Barjora, Dist- Bankura and ii) Bikash Mondal (32 yrs) S/o Matar Mondal of Vill Dubrajpur, PS Saltora, Dist Bankura and following seized articles I A.S.I Goutam Kr. Ghosh do hereby lodge a written complaint against the above noted persons to the effect that today i.e 18.09.2022 at 05:25 hours received an information from duty officer of Barjora PS to the effect that two person being riding a motorcycle on Maliara Barjora Road are carrying illegal liquor with a view to supply them at different shops and hotels in exchange of money. After receiving this information I informed the matter to I.C Barjora P.S and as per his direction I along with accompanying force proceeded towards Maliara Barjora pitch road to work out the information. I accordingly placed NAKA near Ghutghoria Bus stand morh .At around 05.55 HRS I found two persons on a black coloured Glamour Motorcycle vide regd No WB 68L 7405 carrying two bags fitted on the rear side of the motorcycle. We signaled the motorcycle to stop and accordingly the aforesaid motorcycle stopped to our signal. We asked for their identity and the rider and the pillion rider identified themselves as(i) Goutam Pal (48 Yrs) S/o Aswini Pal of Vill Rajmadhabpur , P.S- Barjora, Dist- Bankura and (ii) Bikash Mondal (32 yrs) S/o Matar Mondal of Vill Dubrajpur, PS Saltora Dist Bankura . I checked the bags which were fitted on the rear side of the motorcycle and found one Bag which was fitted on the right side contained a total of 03 cartoon boxes each containing 20 Bottles of country spirit measure 600 ml each in sealed condition styled as CAPTAIN (Country Spirit) STRENGTH 60 UP, IFB Agro Industries Limited (MRP Rs. 155/- each) whereas the bag which fitted on the left side contained a total of 06 Carteen boxes each containing 20 Bottles country spirit measure 600 ml each in sealed condition styled as CAPTAIN (Country Spirit) STRENGTH 60 UP, IFB Agro Industries Limited (MRP Rs. 155/- each). I asked them to produce any valid documents in respect of such amount of Liquor in his possession but he could not produce any valid documents. On being further asked he stated that he was selling liquor and supplying them to different hotels and shops in exchange of money illegally since long. I also asked them to produce valid papers in respect of the Motorcycle but they also failed to produce any papers / affiliation of the said motorcycle

As such, I seized the following articles from his possession after preparing proper seizure list duly signed by the witness in between 06.15 hrs to 06.55 hours. No public witness agreed to sign in the seizure list, so, I took signature of the accompanying police personnel in the seizure list and arrested him after obtaining all legal formalities regarding arrest rule and guide lines of N.H.R.C during the time of arrest as he violated the provisions of Bengai Excise Act, 1909 by storing and selling Liquor (Country Spirit) without license. I collected sample from the following seized items and labeled the same in presence of witnesses as noted below:-

Seized Articles

- 1) 180 bottles(In 09 cartoon boxes, "peti") of country spirit measure 600 ml each in sealed condition styled as CAPTAIN (Country Spirit) STRENGTH 60 UP, IFB Agro Industries Limited (MRP Rs. 155/- each) with two carrying bags from the exclusive possession of Goutam Pal (48 Yrs) S/o Aswini Pal of Vill Rajmadhabpur , P.S- Barjora, Dist- Bankura and Bikash Mondal (32 yrs) S/o Matar Mondal of Vill Dubrajpur, PS Saltora, Dist Bankura under proper section of law.

2) One bottle of country spirit measure 600 ml in sealed condition styled as CAPTAIN (Country Spirit) STRENGTH 60 UP, IFB Agro Industries Limited (MRP Rs. 120/-) collected from sl no. i.

03) One Black coloured Hero Glamour Motorcycle vide regd No WB 68L 7405

Under the above circumstance, I pray before you to start a case under proper section of law against accused persons Goutam Pal (48 Yrs) S/o Aswini Pal of Vill Rajmahabpur, P.S- Barjora, Dist- Bankura and Bikash Mondal (32 yrs) S/o Matar Mondal of Vill Dubrajpur, PS Saltora, Dist Bankura under proper section of law.
