In producing herewith arrested accused persons named (i) Guiram Bauri (56Yrs) S/o Lt. Haradhan Bauri of Vill- Nirisha, P.S- Barjora, Dist- Bankura (ii) Paban Bauri (48 Yrs) S/O Lt. Badal Bauri of Vill- Bistahma, P.S- Barjora, Dist- Bankura I, S.I Subham Roy Chowdhury do hereby lodge a written complaint against the above noted persons to the effect that on 19.09.2023 at 03.05 hours received an information from reliable source that one person namely Guiram Bauri has long been manufacturing, possessing, transporting of I/D liquor and presently keeping huge stock of the I/D liquor at his house for sale. After receiving this information I informed the matter to I.C Barjora P.S and as per his direction I along with accompanying force proceeded towards Nirisha village to work out the information. We reached at Nirisha village at about 04.15 hrs and had been to the house of the said accused. Seeing police some unknown persons from the courtyard of the accused fled away. I could detain there two persons and asked about his identity. On being asked they disclosed his name and identity as (i) Guiram Bauri (56Yrs) S/o Lt. Haradhan Bauri of Vill- Nirisha, P.S- Barjora, Dist- Bankura (ii) Paban Bauri (48 Yrs) S/O Lt. Badal Bauri of Vill- Bistahma, P.S- Barjora, Dist- Bankura and also informed that is the house of Guiram Bauri (56Yrs) S/o Lt. Haradhan Bauri of Vill- Nirisha, P.S- Barjora, Dist-Bankura. I found few containers, Handi etc at the courtyard of his house. As such I along with force and the said accused/ house holder started a search his house. I interrogated him about the purpose of the manufacturing and stocking of the liquid said to be ID Liquor. He replied it was his business. On being asked he could not show any documents/papers in support of the possession of the said articles. Then I interrogated another person namely Paban Bauri (48 Yrs) S/O Lt. Badal Bauri of Vill- Bistahma, P.S- Barjora, Dist- Bankura and it came to learnt that he used to come to the house of Guiram Bauri to purchase I/D Liquor for selling as well as for his personal consumption.

As such, I seized the following articles from his possession after preparing proper seizure list duly singed by the witness in between 04.45 hours and 05.15 hours and arrested the above noted persons after obtaining all legal formalities regarding arrest rule and guide lines of N.H.R.C during the time of arrest as he violated the provisions of Bengal Excise Act, 1909 by storing and selling Liquor (Country Spirit) without license. I collected sample

from the following seized items and labeled the same in presence of witnesses as noted below:-

Seized Articles

- i) One (01) plastic Jar containing approx 07 liters of liquid supposed & reportedly to be Illicit Distillation liquor.
- ii) One (01) plastic Jar containing approx 05 liters of liquid supposed & reportedly to be Illicit Distillation liquor.
- iii) Two (02) Samples each of 375 ML is taken out from the SL no. (i) & (ii) which are marked as Exhibit 'A' & 'B' respectively.
- iv) One aluminum handi fitted with a small plastic pipe which is used as distillation apparatus.

Under the above circumstance, I pray before you to start a case under proper section of law against accused persons (i) Guiram Bauri (56 Yrs) S/o Lt. Haradhan Bauri of Vill-Nirisha, P.S- Barjora, Dist- Bankura (ii) Paban Bauri (48 Yrs) S/O Lt. Badal Bauri of Vill-Bistahma, P.S-Barjora, Dist-Bankura and arrange for its investigation.
