The fact of the case is that today on 30.08.2023 during performing my Spl. mobile duty vide GDE no- 1286 Date- 30:08.2023, during performing my said duty at 09:35 krs. I received an information from my reliable source that the above noted arrested person selling ID liquor illegally in his house. Accordingly, I informed the fact to my O/C and as per direction of my O/C, I along with C/890 Bup! Some, C/1595 Ganesh Mahanta left for Saulia village to work out the information. At 09:55 hrs arrived at Saulia village and as per source information held raid in the house of the accused person. After seeing police party he tried to fled away, but we managed to detained him and after detained, we searched inside the bedroom his house and found that he stocked a plastic Jariken containing approx. 20 ltrs liquor having strong smell of ID liquor. On interrogation it could be learn that he selling this ID liquor in the locality since long. I asked to produce for any valid documents in respect of selling of this ID liquor, but he is unable to produce any permission, or any valid documents in respect of this.
