Sir,

In producing here with the arrested accused person namely- Ashoke Bauri @ Hadal (45Y) S/O-Lt Naran Bauri of Village- Ramkanali, PS- Beliatore, Dist- Bankura along with the following seized articles 1) One 10 ltrs plastic jerrican containing approx. 10 ltrs of liquor having strong smell of ID liquor 2) One 10 ltrs plastic jerrican containing approx. 08 ltrs of liquor having strong smell of ID liquor and 3) Two bottle of 375 ml containing about 375 ml liquor having strong smell of ID liquor in each bottle collected from the seized jerrican (Sl No- 01 & 2) with original seizure list.

The fact of the case is that today on 15.09.2023 at about 18:25 hrs. while performing my mobile duty vide GDE no- 638 Date- 15.09.2023 and CC No- 2084/23 Date- 15.09.2023. I received an information from my reliable source that the above noted arrested person is selling ID liquor illegally in his house at Village- Ramkanali, PS- Beliatore, Dist- Bankura. Accordingly, I informed the fact to my O/C and as per his direction. I along with C/902 Moloy Mondal, C/736 Biswanath Bauri and NVF 288 Ashis Mahata left for Ramkanali village to work out the information.

At about 19:05 hrs myself along with my accompanying force arrived at Ramkanali village and as per source information held raid in the house of the accused person namely Ashoke Bauri. After seeing police party, he tried to fled away, but we managed to detain him and after detaining him, we searched inside the room of his house and found two jerrican - 1) One 10 ltrs plastic jerrican containing approx. 10 ltrs of liquor having strong smell of ID liquor 2) One 10 ltrs plastic jerrican containing approx. 08 ltrs of liquor having strong smell of ID liquor. I interrogated him, during interrogation he admitted that he is selling this ID liquor in the locality since long. Thereafter I asked him to produce any valid document in respect of selling such Id liquor but he failed to produce any valid document or to give any proper explanation.

Accordingly, I seized 1) One 10 ltrs plastic jerrican containing approx. 10 ltrs of liquor having strong smell of ID liquor 2) One 10 ltrs plastic jerrican containing approx. 08 ltrs of liquor having strong smell of ID liquor & 3) two bottle containing approx 375 ml of liquor having strong smell of ID liquor in each collected from both the seized jerricans as sample under proper seizure list duly signed by the my accompany force as seizure witnesses as no public witness came forward to sign in the seizure list as seizure witnesses and arrested the accused person namely- Ashoke Bauri @ Hadal (45 yrs) S/O- Lt Naran Bauri of Village- Ramkanali, PS- Beliatore, Dist- Bankura after maintaining all the legal formalities of arresting rule as directed by Hon'ble Supreme Court and Hon'ble N.H.R.C.

Under the above fact and circumstance, I pray before you to start a specific case against the arrested accused person namely Ashoke Bauri @ Hadal (45 yrs.) S/O- Lt Naran Bauri of Village-Ramkanali, PS- Beliatore, Dist- Bankura under proper section of law and arrange for its investigation.
