Sir,

With due respect and humble submission, I beg to state that, I ASI Tapas Dey of Bishnupur P.S. along with C/955 Ashis Boxi, C/571 Nandaji Pandy and NVF Subhas Bardhan were performing mobile patrolling duty in PS area, vide Bishnupur PS GDE No- 73, Dt- 02.09.23, and C.C. no- 3194/23, Dt- 02.09.23. During my patrolling duty, at about 00.05hrs, while I was moving near Bhagat Singh Morh, received information from local that one person is lying with injury on road, near Jorbangla Lodge. After getting the information, we reached to the spot, i.e. Bishnupur-Joypur Road, near Jorbangla Lodge, and saw that one middle aged person, only wearing apparel is green color half-pant, is lying on right side of the road, in injured condition. I saw bleeding injury on head, nose, and abrasion injuries over body. The person was in unconscious stage, and apparently seems as a vagabond. At this late hour of night, finding no other alternative, I managed to shift the injured person to Bishnupur District Hospital, for his necessary medical treatment. Primary enquiry reveals that, any vehicle dashed the person. Due to rash and negligent driving of any vehicle (which is untraced so far) the incident occurred.

I informed the information, and circulate the picture of injured to local persons and meantime the identity of the person is known as Madhusudan Bauri (58yrs) S/o- Lt Kalipada Bauri of Natunpukur, Ward no- 15, PS- Bishnupur, Dist- Bankura. Family members of the person is informed and they appeared at hospital.

In this circumstance, I submitted a *suo-moto* complaint as first information report, before you to take necessary action as per law.
