NO 22, Village - Moukura, at Karmakar Para, Post Office - Moukura and Police Station Sarenga, ~~district~~ ^(Narmada) ~~police station - Raipur~~, District- Bankura and presently residing at 106/e/2/c/1, Maharaja Nanda Kumar Road (south), Baranagar, P.O. and P.S. Baranagar, District North 24 parganas, Kolkata-700036.

My father, namely, Baidyanath Karmakar alias Dhaura since deceased, was the original owner in respect of total land measuring about total land 3.19 Acre, decimal of land of numbers are 56, 65, 148, 410, 423, 427, 444, 446, 457, 496, 505, 508, 513, 517, 519, 561, 563, 565, 567, 613, 336/760, 410/764, 408/853, 407/858, 426/862, 483/867, 969/969, 410/970 under khatian Number - 432 and J.L. Number - 22, Mouza - [022] Moukura, Block - Sarenga [15], Police Station Sarenga and District - Bankura [01] is mentioned under L.R. khatian as Record-of-Rights.

The said Baidyanath Karmakar died intestate behind me and my sister, namely, Nivedita Jana Karmakar as his sole legal heirs and successors and after his intestate death the said land devolved and/or devolves upon me and my sisters in equal shares.

Since I am residing far away from my native village for my avocation, taking advantage of my absence in a considerable length of time, Tapan

Karmakar and Tapas Karmakar local residents of Karmakar Para at Village – Moukura have criminally trespassed in my land, chalked out a plan to grab our property and entered into deep rooted criminal conspiracy with each other and constructed illegal and unauthorized construction thereon without taking any permission from me or my sister and without any sanctioned plan from the local Gram Panchayat.

The said incident has come to my knowledge only on 04/09/2023 when I went to my native village even the said Tapas Karmakar and Tapan Karmakar resisted me to enter into my premises and threatened me with dire consequences and they did so with intent to cause alarm by using filthy languages and criminally insulted and intimidated me.

From the modus operandi, it is crystal clear that, I am in actual physical possession of property and the said persons entered into unlawful and their intention were to intimidate and annoy me in possession of property and they did so with intent to cause alarm by using filthy languages and criminally insulted and intimidated me and thereby committed offences punishable under the provisions of the Indian Penal Code.

I, therefore, request you to investigate the matter and take necessary steps against the said Tapan Karmakar and Tapas Karmakar both residents of Karmakar Para at Village – Moukura within your Police Station for unearthing the crime as a whole.
