Sir,

This is to inform you that, I, Rajeev ranjan kumar, S/O- Akhileshwar Prasad, A.E & SM, Saltora CCC under Bankura (D) Division along with the Office team comprising of 1) Biplab Mandi, s/o- Dharandas Mandi, DE S&IP, Bankura rm office 2) Shankar ch. Dana s/o- Lt.Rabindranath Dana, SO S&LP, Bankura rm office & 1) Akash Bhattacharya, s/o- Apadesh Bhattacharya, o.e. saltora ccc 2) Suresh Kar s/o- Kanailal Kar, jr. engg-ii, saltora ccc conducted a raid programme on 12th Sept, 2023 at about 14:02 hrs to 14:25 hrs in the premises of Sri. Tarapada Mandal S/o- Sarnan Mondal vill+ P.O.- Kultuka P.S- Saltora, Dist-Bankura. During inspection it is found that Sri. Tarapada Mandal and his family members were enjoying electricity dishonestly by bypassing of energy meter. As a result of this WBSEDCL has incurred huge loss of revenue. After that we have disconnected the service connection. The contractual load of the disconnected connection was 0.7 KW and as a token of evidence we have seized following items:

1. PVC single core cable (approx 30 feet long).

After detecting theft of electricity we prepared the inspection report and then we seized the articles as mentioned above. Thereafter we prepared seizure list on spot & left his premises at 14:25 hrs.

So undersigned want to lodge a complaint against Sri Tarapada Mandal S/o- Sarnan Mandal U/s 135(i)(b) of electricity act, 2003 and as amended on 2007.

That theft causing huge loss to WBSEDCL and he is liable to prosecution under section 135 (i) (b) of the electricity act, 2003. This complaint may be treated as FIR.
