Dear Sir,

In producing herewith the following article 1. Three nos multi core PVC Cable of approximate length 7 (Seven) feet with Hooking arrangements seized under proper seizure list, duly not signed by available witnesses I, Mr. Shouvik Malik (27 yrs), S/O- Mr. Bikash Malik, Assistant Engineer (E) & Station Manager, Sarenga Customer Care Centre, WBSEDCL, Sarenga, Bankura do hereby lodge complaint against Krishna Pada Mondal, S/O- late Phanibhusan Mondal of Village- Goalbari, PO-Shukhadali, P.S- Sarenga, Dist.- Bankura, to the effect that today (i.e on 13/09/2023) myself along with, Sri. Anjan Mahata, S/O- Mr. Nabakumar Mahata, J.E (E)(Gr-II) and Kaushik Mahato, S/O- Sisir Mahata, Sr. TSH, Sarenga CCC at about 2.00 pm acting on a tip-off, myself accompanied by Biplab mandi, S/O- Dharamdas Mandi, D.E(S&LP) along with Shankar Chandra Dana s/o-Lt. Rabindranath Dana S.O(S&LP) of Bankura Regional Office, WBSEDCL went to the village Goalbari to work out on one source information. Around 02:00 pm of date we reached at the village Goalbari and inspected the electric lines near the agriculture premise of the occupier Krishna Pada Mondal and during inspection about 2.00pm the user Krishna Pada Mondal, found stealing electricity dishonestly at his occupied agriculture premise by direct hooking from nearest LTOH line of WBSEDCL and has caused financial loss to WBSEDCL. The load is assessed as 1.492 K.W during preparing inspection report at the spot.

Thus the User cum occupier Krishna Pada Mondal, S/O- LT. Phanibhusan Mondal has violated the provision of section 135(1)(a) The Electricity Act 2003 (Amendment 2007).

Hence I seized the above noted article under proper seizure list duly not signed by available witnesses following disconnection of the unauthorized electric line by removing the hooking devices and producing before you with a request to initiate a cause u/s 135(1)(a) of The Electricity Act 2003 (Amendment 2007) against Krishna Pada Mondal, S/O- late Phanibhusan Mondal of Village- Goalbari, PO-Shukhadali, P.S- Sarenga, Dist.- Bankura and arrange for its investigation. It is to be mentioned that some local villagers were present there but they refused to sign as local witness in the seizure list and Inspection Report. It is also to be mentioned that we disconnected the unauthorized connection at that premise and left the premise at about 02:30 pm on the same day.
