In producing herewith seized article i.e. (1) 01(one) plastic made 10 (ten) litters container loaded with approx 09 (Nine) litters liquid appearing to have been illicit liquor after collecting sample in a (2) one 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container. (3) Some plastic glass & (4) one funnel from the premises of above noted Rabi Lochan Saren. I, do hereby submit complaint against accused Rabi Lochan Saren S/O Lt. Saban Saren of village Badageria, P.O- Mukundapur P.S-Simlapal, Dist-Bankura. to the effect that on 22.09.23 at about 12:40 hrs. as per source information I along with force and local village police held raid at Badageria village, P.O- Mukundapur P.S-Simlapal house premises of Rabi Lochan Saren S/O Lt. Saban Saren and found that above noted Rabi Lochan Saren was selling illicit liquor in a polithin glass from a plastic container. On seeing Police party he fled away and managed to conceal himself behind a bush. The raid team found I/D liquor and other related articles in the house premises of above noted Rabi Lochan Saren which was possessed and getting sold illegally. So I, seized the following articles in between 12.45 hrs to 13.10 hrs (1) 01(one) plastic made 10 (ten) litters container loaded with approx 09 (Nine) litters liquid appearing to have been illicit liquor after collecting sample in a (2) one 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container.(3) Some plastic glass & (4) one funnel from the premises of above noted Rabi Lochan Saren under proper seizure list as alamat.

So, I pray before you to start a Cog case under proper section of law against accused Rabi Lochan Saren S/O Lt. Saban Saren of village Badageria, P.O- Mukundapur, P.S-Simlapal, Dist-Bankura and arrange for its investigation.
