In producing herewith the following article i) PVC Cable two Coresingle wire 06mtr(Approx) with hooking device seized under proper seizure list, duly signed by available witnesses, I Sri Rajsekhar Gorai, (Age - 48 Years) S/O - Sri Narugopal Gorai, Station Manager of Simlupal CCC do hereby lodge complaint against Abed Ali Khan, S/O Hanif Khan, Residence of Ghoradhara, PO-Machatora, PS - Simlupal to the effect that to day (22.09.2023) at about 12.10P.M acting on a tip-off myself accompanied by

had gone to village Ghoradhara to work out the information. Around 01.40P.M. we reached at village Ghoradhara and inspected the electric line. During inspection the owner cum occupier Abed Ali Khan has been found stealing electricity dishonestly at his Domestic premises by way of direct hooking from nearby LTOH line and has caused financial loss to WBSEDCL. The load is assessed 0.190KW. The inspection team left the premises at about 02.05P.M.

Thus the owner cum occupier Abed Ali Khan has violated the provision of section 135(I)(a) of Electricity Act 2003(Amendment 2007).

Hence I seized the above noted article under proper seizure list duly signed by available witnesses, following disconnection the electric line by removing hooking device and produce before you with a request initiate a case U/S - 135(I) (a) of Electricity Act 2003(Amendment 2007) against Abed Ali Khan, S/O Hanif Khan, Residence of Ghoradhara, PO-Machatora PS - Simlupal, Dist - Bankura and arrange for its investigation.

The result of the investigation may kindly be communicated after its completion for onward action.
