Sir,

In producing herewith 01 (one) arrested accused person namely Kailash Chowdhury S/O - Late Debaki Chowdhury of Chhatna kamarkuli Raillinepar, PS - Chhatna, Dist. - Bankura along with seized huge quantity of country spirit bottles styled as "बाष्पार", "Dil Se" and "Dil Khush". The fact is that on 01.10.23 night at 04.15 hrs I along with C/1170 Binoy krisna Mahato and NVF/105 Soumen Sing Sardar was performing night RT mobile duty at Dubrajpur more under Chhatna P.S. vide Chhatna P.S. GDE. No. 1404 and C.C. No. 2347/2023, both dated - 30.09.23 when I received a credible source information that, one person namely Kailash Chowdhury S/O - Late Debaki Chowdhury of vill. - Kamarkuli raillinepar, P.S. - Chhatna, Dist. - Bankura has stored a huge quantity of country spirit in his house and selling the same illegally in the locality. I shared the information with I/C Chhatna P.S., and as per his direction at 04.35 hrs I held raid in the house of Kailash Chowdhury at Chhatna kamarkuli raillinepar. In course of holding raid I searched the house of Kailash Chowdhury very carefully and during search I found 1] 12 bottles country spirit styles as "बाष्पार" each bottle contains 300 ml. and price 28.00/- Rs. (total quantity: 12 x 300 mls. = 3.6 liters and total value 12 x 28 = 336/- Rs. ), 2] 15 bottles country spirit styles as "Dil Se" each bottle contains 300 ml. and price 25.00/- Rs. (total quantity : 15 x 300 mls. = 4.5 liters and total value 15 x 25 = 375/- Rs. ) and 3] 34 bottles country spirit styles as "Dil Khush" each bottle contains 600 ml. (total quantity : 34 x 600 ml = 20.4 liters and total value : 34 x 55 = 1870/- Rs.) in his house. I asked him to produce valid documents in respect of stoking the huge quantity of country spirit bottles found in his house but he failed to produce the same. In my through interrogation he admitted that, since long he has been stocking such types of country spirit in his house and selling the same secretly for his personal gain. After that at 05.25 hrs I seized the country spirit bottles under proper seizure list and at 05.45 hrs I arrested the accd. Kailash Chowdhury S/O - Late Debaki Chowdhury of Chhatna Kamarkuli raillinepar, P.S. - Chhatna, Dist. - Bankura after maintaining all legal formalities of arrest and also observed the guidelines of NHRC and Apex court regarding arrest.

Hence, I request you to lodge a FIR against the arrested accused person namely Kailash Chowdhury S/O - Late Debaki Chowdhury of Chhatna Kamarkuli raillinepar, P.S. - Chhatna, Dist. - Bankura under section 46A B.E. Act, 1909 and arrange for investigation.
