Sir,

In producing herewith one (01) arrested accused person namely Sandip Bauri s/o Swapan Bauri of Vill. - Agrabaid, P.O. - Manihara, P.S. - Kashipur, Dist- Purulia along with seized illegal firecrackers such as 1] Flower pots Big (Jharbati) 140 packets, total price 140 x 120 = 16800/- Rs, 2] Deluxe Fire pots (Tubri) 03 packets, total price 3 x 120 = 360/- Rs, 3] Tumpa Siwer tree 02 packets, total price 2 x 1000 = 2000/- Rs, 4] Generater Colour Anar (Tubri) 5 packs, total price 5 x 300 = 1500/- Rs, 5] Olympic torch 5 packets, total price 5 x 14 = 70/- Rs, 6] Golden light 05 packets, total price 5x 140 = 700/- Rs, 7] Seven shot - 7 packets, total price 7 x 1000/- = 7000/- Rs, 8] Chutu Putu (Atasbaji) 48 packets, total price 48 x 12 = 576/- Rs, 9] Shaktman Chocolate bomb - 03 packets, total price 3 x 300 = 900 Rs, 10] Comation komal - 01 packet, total price 1 x 300 = 300/- Rs, 11] KR (Shot) 7 packets, total price 7 x 70 = 490 /- Rs, 12] Champion Dhumketh 04 packets, total price 4 x 1000/- = 4000/- Rs, 13] Amra Fatka 01 Bag, total price 10000/- Rs, 14] Alur fatha 1 bag, total price 5000/- Rs. (Total price Rs.- 49696) under proper seizure list.

The fact is that today (16.10.23) at 17.45 hrs I received a source information that an unknown person was selling illegal firecrackers at Jhantipahari linepar under Chhatna P.S. I shared the information with I/C Chhatna PS and as per his direction I along with C/460 Rabi kumar Rajak and C/454 Alok kumar Mahato left to work out the information. I along with force at 18.45 hrs reached at Jhantipahari linepar and found an unknown person with huge quantity of illegal firecrackers. I asked him to produce valid license in respect of possessing such kind of illegal firecrackers but he failed to produce the same. On my repeated interrogation he disclosed his identity as Sandip Bauri s/o Swapan Bauri of Vill. - Agrabaid, P.O. - Manihara, P.S. - Kashipur, Dist. - Purulia and admitted that he has been storing and selling such kind of illegal firecrackers in public for a long time for his personal gain. After that from 19.05 hrs to 19.55 hrs I seized the aforesaid illegal firecrackers from his possession under proper seizure list. I asked local public to remain present during search and seizure and also put signature in seizure list but none appeared for the same. The police force accompanying me signed on seizure list and accused put his signature on the seizure list. After that I arrested the said Sandip Bauri s/o Swapan Bauri of Vill. - Agrabaid, P.O. - Manihara, P.S. - Kashipur, Dist. - Purulia after maintaining all legal formalities of arrest and also observed the guidelines of NHRC and Apex court in this regard.

As the firecrackers were possessed by arrested accused, Sandip Bauri illegally with a view to sell the fire crackers in public vicinity in contravention of the recent order passed by Hon'ble High Court, Calcutta Order described in WPA (P) 292 of 2021 with CAN 1A No: CAN 1 of 2022, Sabuj Mancha & Anr. Vs The State of West Bengal and others, without having any valid fire license. This substance in his possession in such manner is portray the negligent conduct with respect to explosive substance which may cause endanger to human life. This act of the apprehended person for posses and selling the fire crackers including sound fire crackers in lieu of money vividly

violates the section 285/286/188 of IPC & 24 /26 of West Bengal Fire Service Act.1950 and 31(A) of Air (Prevention & Control of Pollution) Act, 1981. During raid I asked local people to remain present and assist the raid but they refused to assist police and were not ready to put their sign on the seizure list. Finding no other alternative, I bound to took police witness for the seizure. The police force accompanying me signed on seizure list and accused put his signature on the seizure list.

In view of above circumstances, I pray that a specific case U/S - 285/286/188 of IPC & 24 /26 of West Bengal Fire Service Act.1950 and 31(A) of Air (Prevention & Control of Pollution) Act, 1981 may kindly be started against the arrested accused person namely Sandip Bauri s/o Swapan Bauri of Vill- Agrabaid, P.O- Manihara, PS - Kashipur, Dist- Purulia and arrange for its investigation.
