Being puzzled I <sup>was</sup> clicked on the link and after a few seconds Rs 25000 was deducted from my Bank Account No - 10480366371; M.T.P.S; BANKURA. IFSC: SBIN0006608. And which was transferred to INB IMPS/P2A/318116960373/xxxxxxx419HDFC 4597873162096 AT 99922 INTERNET BA. And again message was sent requesting OTP for another 50,000 deduction.

Then and there, I realised that I am victimised by any fraud person. So quickly, I went to Bankura S. B. I. Branch and blocked all my credit cards, Net Banking and all other banking transaction etc.

Then I complained to CYBER CRIME Department through cyber crime portal. They took my grievance and hold the bank account in which my Rs 25,000 was transferred. My grievance Acknowledgement no is 33206230008116.

Now Sir, I request you to kindly consider my case favourably and Sir, arrange the necessary steps, so that I get my fraud amount Rupees and the fraud person would be punished as per your law, as early as possible and oblige.
