**Sub: - Complaint against Mukta Mondal (52) S/O Lt Abanidhar Mondal of Vill.-
Kharbona, P.S.- Saltora, Dist- Bankura**

Sir,

In producing herewith the arrested accused namely Mukta Mondal (52) S/O Lt Abanidhar Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura along with seized articles i.e. 1. One Jarikan ID liquor, contain approx 20(Twenty) ltrs in which one 01 (one) bottle approx 375 ML collected as sample, 2. 10(Ten) bottle Captain ,600 ML each, 01 (one) bottle 600 ML collected as sample . I beg to submit that on 14/10/2023 at about 18:30 hrs when myself along with C/537 Tarun Ch Gope , C/1579 Krishna Pada Patra & NVF Susanta Mondal were performing evening mobile duty vide Saltora PS C.C No. 2906/23 dtd 14.10.2023 then I received a credible source of information that one Mukta Mondal (52) S/O Lt Abanidhar Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura is involved in selling country sprit from Maa Tara Hotel , Krishnapur under Saltora P.S, Dist.-Bankura without any valid license. Accordingly I informed the matter to O/C Saltora PS and as per order of O/C Saltora PS. I along with accompanying force left for Krishanpur area, under Saltora P.S to work out the information. Thereafter we reached at Ma Tara Hotel ,Saltora to Mejia road side and found that some persons who were sitting inside of the hotel of said accd person. Seeing the Police vehicle they started to flee away. We chased behind them but all of them managed to escaped only we apprehended Owner/Seller person namely Mukta Mondal (52) S/O Lt Abanidhar Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura

I along with force in between 19:05 to 19:35 hrs searched into Maa Tara Hotel of accd person and found . 1. One Jarikan ID liquor, contain approx 20(Twenty) Ltrs & 10(Ten) bottle Captain ,600 ML each and an being asking he confess that he has no valid license and he illegally selling I.D liquor & Country spirit. As the accd person illegally selling I.D liquor & country sprit from his hotel to customers with exchange of money for wrongful gain and he is running this illegal business since long. So I seized above noted articles after preparing proper seizure list duly signed by the police witnesses as no public witnesses agree to signed the S/L . I collected sample from the above and sealed and labeled in presence of police party which is duly signed by them. Then I arrested the accused at 19:45 hrs after observing all legal formalities laid down in Cr.P.C and Hon'ble Apex Court.

I therefore pray that a specific case under Bengal Excise Act may kindly be started against accused person namely Mukta Mondal (52) S/O Lt Abanidhar Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura and arrange for its investigation.
