Subject: Prayer for lodging FIR

Sir,

With due respect, I do hereby lodge written complaint against unknown miscreant(s) to the effect that on 08.09.23 at 11.45 hrs. SI Laxmikanta Singha Mahapatra , Duty Officer of Taldangra PS received a written information from Dr. Biswanath Bauri , M.O of Taldangra Rural Hospital that "one patient namely Aparna Kundu D/O- Lt. Ajit Pal , W/O- Lt. Joydeb Kundu of vill- Kharkhari , PO- mamra, PS-Taldangra , Dist- Bankura was brought to this Hospital in dead condition at 11:20 hrs. on 08.09.23. As per the history no specific cause of death could be detected. So, kindly arrange for post mortem examination for this patient to determine exact cause of death". On the basis of this written information Taldangra PS U/D Case No. 24/23 dated 08.09.23 was started and per endorsement of I/C Taldangra PS, SI Sambhunath Banerjee of Taldangra PS enquired this U/D Case. During Enquiry he along with C/1294 Sanjib Acharjee of Taldangra PS had been to Taldangra Rural Hospital and prepared Surathal Report ,Dead Body Challan over the dead body of deceased Aparna Kundu (47 yrs.), D/O- Lt. Ajit Pal , W/O- Lt. Joydeb Kundu of vill- Kharkhari , PO- Mamra, PS- Taldangra , Dist- Bankura after maintaining all legal formalities in presence of her daughter, son-in-law and sister. During enquiry from the statement of relatives of the deceased and other witnesses it revealed that deceased Aparna Kundu was found in dead condition at her own house at village Kharkhari, PS-Taldangra, Dist-Bankura due to any unknown cause. So, SI Sambhunath Banerjee send the dead body of deceased Aparna Kundu to the B.S.M.C Morgue, Bankura for P.M Examination to ascertain the actual cause of death under proper escort through C/1294 Sanjib Acharjee of Taldangra PS along with all connected papers.

During enquiry on 17.09.23, SI Sambhunath Banerjee send a prayer to the concern authority for supply the P.M Examination Report. Subsequently on 06.10.23 I SI Satyajit Mahanty, in-charge of Amdangra OP, PS Taldangra received P.M Examination Report of deceased Aparna Kundu, vide P.M No. 1014/23 dated 08.09.23. Perused the report and found that Dr. Tanmoy Sardar, Associate Professor, Dept. Of FMT , B.S.M.C Bankura conducted P.M Examination of deceased Aparna Kundu on 08.09.23 and he opined in his report that "Death was due to manual strangulation associated with smothering homicidal in manner" No any specific complaint received from the end of the relatives of deceased till now.

Therefore I pray before your kind honour that a specific case u/s- 302 IPC may kindly be started against unknown miscreant(s) and arrange for its investigation.
