Respected Sir,


In producing herewith the arrested persons namely i. Bipod Taran Mahanta (approx 35 yrs) S/o- Lt Gobardhan Mahanta of vill- Dhundabad, PS- Salanpur, Dist- Paschim Bardhaman, driver of Bolero Pickup bearing No- JH 10 CQ 2069 and helper of said vehicle namely ii. Jitesh Bauri (Approx 19 yrs) S/O- Dilip Bauri of vill- Dhundabad, PS- Salanpur, Dist- Paschim Bardhaman, and the seized above noted Bolero Pickup loaded with coal, guarding by 33 packet sealed water bottle and covered with one grey and white colour tarpaulin under proper seizure list duly signed by the accused drivers and witnesses. I beg to report that on 07.11.2023 at about 17:05 hrs while I was engaged in PS mobile duty vide Indas P.S C.C No- 2589/23 dtd. 07.11.2023, near Kumna under Indas PS, I noticed that one bolero Pick up was coming through the road from Rasulpur side. Seeing Police party the driver of the vehicle started to drive the vehicle in a suspicious manner. After a hot chase we were succeed to apprehend the vehicle bearing No- JH 10 CQ 2069. After apprehension I started to interrogate the driver and helper of the vehicle. After prolong interrogation they disclosed there identity as above and they confessed that they were carrying the illegal coal from the coalmine of Asansol and in the vehicle No JH 10 CQ 2069 surrounding with sealed water bottle as if any one, specially Police could not be able to notice the coal. I asked the drivers to produce legal documents in respect of loaded coal. But the driver could not produce any valid documents. On interrogation they confessed that they had no legal documents in respect of the coal and they have doing this job in connivance with the owners of the above noted Bolero Pickup. Finding no other alternative I have seized the said Bolero Pickup bearing No- JH 10 CQ 2069 loaded with coal, 33 petty of sealed water bottle covered by one grey and white colour tarpaulin in-between 17:25 hrs to 17:45 hrs under proper seizure list. I requested the local people to sign in the seizure list but nobody found willing to sign in the seizure list. Accordingly my accompany force signed in the seizure list, and I arrested the above noted drivers namely i. Bipod Taran Mahanta (approx 35 yrs) S/o- Lt Gobardhan Mahanta of vill- Dhundabad, PS- Salanpur, Dist- Paschim Bardhaman, driver of Bolero Pickup bearing No- JH 10 CQ 2069 and helper of said vehicle namely ii. Jitesh Bauri (Approx 19 yrs) S/O- Dilip Bauri of vill- Dhundabad, PS- Salanpur, Dist- Paschim Bardhaman maintaining all legal formalities.

I, therefore, pray before you that a specific case may kindly be started in this regard under proper section of law and arrange for its investigation.


