I, Chittaranjan Ghosh, S/O Sri Nilkantha Ghosh, D.E. & Station Manager, Khatra Customer Care Centre, W.B.S.E.D.C.L. being empowered by Electricity act 2003 amended in 2007 do here lodge complain against Sri Anup Das, S/O Late Pachanan Das, Vill Dharampur, Post Kankradara, PS Khatra, Dist Bankura, u/s 135 (i)(a) of the Electricity act 2003 amended in 2007 to the fact that received an information that Sri Anup Das is committing theft of electricity by direct hooking from LTOH line of W.B.S.E.D.C.L. for the purpose of running his domestic house.

A theft of electricity has been detected by direct hooking from LTOH line of W.B.S.E.D.C.L. today on 31.10.2023 time at 11:40 am to 12:00 pm during Supervisory checking along with Sri Sambhujit Pal, S/O Late Sibaram Pal, Jr.Eng. Grade-I, Sri Harendra Nath Mahata, S/O Late Atul Chandra Mahata, Sr.T.S.H. Khatra CCC and Sri Shishir Kr. Mishra, S/O Late Ashok Kr. Mishra, Sr. T.S.H., Khatra CCC and Md. Rabbul, S/O Md. Jalal, Sr. TSH, Khatra CCC. I directed Shishir Kr. Mishra to dehook the hooking cable and he has dehooked the cable which has been seized accordingly. It is estimated that he is consuming 0.350 KW load.

It is well evident that Sri Anup Das has been committing theft of electricity by direct hooking from nearby LTOH line of W.B.S.E.D.C.L. As such he is liable for prosecution 135 (i) (a) of the Electricity act 2003 amended in 2007.
