Sub:- Prayer for lodging FIR

Sir,

In producing herewith one accused namely Tapan Garai (40yrs) S/o Rohit Garai of Bhedua, PS Khatra, Dist Bankura along with seized articles e.g (i) total 4200 (four thousand two hundred) label of different size of "CO-OPERATIVE BIRI" along with 44 bundle Biri having label of "CO-OPERATIVE BIRI" and (ii) 4220 (four thousand two hundred twenty) label of "522 NO. PHOTO" biri along with 45 bundle biri having label of "522 NO. PHOTO", I SI Malay Mahapatra do here by lodged a complaint to the effect that on today (01.11.23) at about 12.10hrs Satya Malla Secretary Bankura Biri Shilpi Co-op. Society Ltd. came at PS and informed that one Tapan Garai S/o Rohit Garai and one Sunil Garai S/o Gurupada Garai both of Bhedua, PS Khatra, Dist Bankura are selling biri by making fake label of Co-operative bidi. They have registration number 319769. After getting this information as per order of I/C Khatra PS myself along with ASI Nagen Das and force left for Bhedua village to work out the information. The informant along with two others also accompanied us. This refers to Khatra PS GDE No. 28 dt. 01.11.23. At about 13.40hrs we arrived at Bhedua village and placed police personnel in front of house of Sunil Garai. Then I went at the house of Tapan Garai S/o Rohit Garai of Bhedua, PS Khatra, Dist Bankura. We disclosed our identity to Tapan Garai and also disclosed the information/allegation which was received against him. We offered him to search us before started searching but he denied to search. We also searched for local witnesses but no one came out to remain present as witnesses during search. Then in presence of representative of Bankura Biri Shilpi Co-op. Society Ltd namely (i) Satya Malla (55) S/o Lt. Dhruba Malla of Kustia, PS Belitore, Dist Bankura (ii) Mohan Garai (58) S/o Lt. Ratan Garai of Shyamdaspur, PS +Dist Bankura (iii) Krista Barik (61) S/o Lt. Haripada Barik of Birbandh, PS Onda, Dist Bankura and in presence of Tapan Garai I started searching at the house of Tapan Garai. During search following articles were found at his house:-


- (i) Total 2000 (two thousand) label used on bundle of bidi upon which "CO-OPERATIVE BIRI" and "কো-অপারেটিভ বিড়ি" was written. Among them five label was taken out as specimen sample.
- (ii) Total 2000 (two thousand) label used on bundle of bidi upon which "কো-অপারেটিভ বিড়ি ২৫টি" was written. Among them five label was taken out as specimen sample.
- (iii) Total 200 (two hundred) label which was used on packet containing bunch of bidi upon which "CO-OPERATIVE BIRI" was written. Among them five label was taken out as specimen sample.
- On all above mentioned three type labels Registration No. 319769 was written.
- (iv) Total 2000 (two thousand) label used on bundle of bidi upon which "৫২২ নং ফটো বিড়ি" and REGD. NO. 2BK31.10.86 were written. Among them five label was taken out as specimen sample.
- (v) Total 2000 (two thousand) label used on bundle of bidi upon which "৫২২ নং ফটো বিড়ি" and "522 NO PHOTO" and Trade mark Registration No. 1191376 were written. Among them five label was taken out as specimen sample.
- (vi) Total 220 label which was used on packet containing bunch of bidi upon which "৫২২ নং ফটো বিড়ি" and REGD. No. 2BK31.10.86 and T.M No. 1191376 were written. Among them five label was taken out as specimen sample.
- (vii) Total 44 (forty four) bundle Biri having label of "CO-OPERATIVE BIRI". Among them one bundle was taken out as specimen sample.
- (viii) Total 45 (forty five) bundle biri having label of "522 No. PHOTO BIDI". Among them one bundle was taken out as specimen sample.

On being asked Tapan Garai failed to give any valid documents in support of his possession of above mentioned label of different company and above mentioned bundle of biri. He also confessed that he prepared bundle of biri with fake label at his house and sale it to different shops. The representative of Bankura Biri Shilpi Co-op. Society Ltd also identified their label as fake label. Accordingly I seized all above mentioned label and bundle of biris under proper seizure list in presence of witnesses and obtained signature of witnesses on the seizure list. Seized articles were properly labelled on spot. The search and seizure process was conducted 13:50hrs to 15:45 hrs. Then I arrested Tapan Garai for possessing fake label and for selling of biri with fake label after observing all formalities of arrest. Then I went at the house of Sunil Garai S/o Gurupada Garai of Bhedua, PS Khatra, Dist Bankura and observing all formalities, searched his house but noting was found there.

So, I pray before you that specific case may kindly be started against Tapan Garai (40yrs) S/o Rohit Garai of Bhedua, PS Khatra, Dist Bankura.
