Sub: Prayer for starting a Cog. Case under Section 46 A (c) Bengal Excise Act. against accused persons namely 1) Bablu Bagdi (Male / Age Approx. 51 Yrs.) S/O Late Rakhahari Bagdi of Vill.- Rudra (Bagdipara), P.O- Rudra, PS. - Ranibandh, Dist. - Bankura and 2) Shaktipada Khan (Male / Age Approx. 59 Yrs.) S/O Late Radhagobinda Khan of Vill.- Rudra (Telipara), P.O - Rudra, PS. - Ranibandh, Dist. - Bankura.

Sir,

In producing herewith the following accd. persons namely Bablu Bagdi (Male / Age Approx. 51 Yrs.) S/O Late Rakhahari Bagdi of Vill.- Rudra (Bagdipara), P.O- Rudra, PS. - Ranibandh, Dist. - Bankura along with seized 01 (One) container (Plastic Jariken) in a Nylon bag and containing supposedly approx. 10 (Ten) Ltrs.

I, ASI Buddhadeb Nandi of Ranibandh PS, would like to draw your kind attention to the fact that today on 14.11.2023, left PS with forces C/ 804 Akhil Chandra Mahata, C/1496 Madhu Das and NVF=- 0110 Basudeb Mandi for performing morning mobile duty vide Ranibandh PS C.C No. 2072/2023 , Dt. 14.11.2023 in course of patrolling duty, around 11.35 Hrs., received a piece of information from my credible source that 02 (Two) person (names and particulars are noted above) have been transporting and selling I/D liquor in open place near Rudra Prathamik Vidyalaya at Vill.- Rudra under P.S- Ranibandh, Dist.- Bankura illegally. People of Rudra, Ramdungri and Charuibandh villages and other adjacent areas are coming there for consuming that I/D liquor and thereby making the area obnoxious. I informed the matter to the I/C, Ranibandh PS and as per his instruction, I left for executing the said piece of information. Around 12.15 Hrs., reached near Rudra Prathamik Vidyalaya at Vill.- Rudra under P.S- Ranibandh, Dist.- Bankura. My source showed me that illegal liquor i.e 01 (One) container (Plastic Jariken) in a Nylon bag in which containing supposedly approx. 10 (Ten) Ltrs. on the right hand of the accused person namely Bablu Bagdi S/O Late Rakhahari Bagdi of Vill.- Rudra (Bagdipara), P.O- Rudra, PS. - Ranibandh, Dist. - Bankura and said plastic glasses on the right hand of the accused person namely Shaktipada Khan S/O Late Radhagobinda Khan of Vill.- Rudra (Telipara), P.O - Rudra, PS. -Ranibandh, Dist. – Bankura . I along with my forces, cordoned off the place and found the aforesaid persons selling and transporting I/D liquor. On seeing Police both the said accused persons tried to fled away by left the container (Plastic Jariken) in a Nylon bag and containing supposedly approx 10 (Ten) Ltrs. improvised deshi liquor and 19 (Nineteen) plastic glasses on the ground. On hot chased myself along with forces able to apprehended the accused Bablu Bagdi (Male / Age Approx. 51 Yrs.) S/O Late Rakhahari Bagdi of Vill.- Rudra (Bagdipara), P.O- Rudra, PS. - Ranibandh, Dist. - Bankura. The accused person namely Shaktipada Khan (Male / Age Approx. 59 Yrs.) S/O Late Radhagobinda Khan of Vill.- Rudra (Telipara), P.O – Rudra, PS. - Ranibandh, Dist. - Bankura able to fled away. Myself along with forces tried to our level best and chased him but unable to apprehended him. I asked the apprehended accused Bablu Bagdi to show documents in support of selling and transporting I/D liquor. He failed to produce any documents. I asked him of his names and address and he stated as noted above and he also stated his accompanied another accused person as stated above. Thereafter, I seized 01 (One) container (Plastic Jariken) in a Nylon bag and containing supposedly approx. 10 (Ten) Ltrs. improvised deshi liquor and 19 (Nineteen) plastic glasses (details in seizure list) under proper seizure list. As all the onlookers denied signing on seizure list, I took the signatures of my accompanying forces on the seizure list. Prepared labels. After that, I arrested Bablu Bagdi (Male / Age Approx. 51 Yrs.) S/O Late Rakhahari Bagdi of Vill.- Rudra (Bagdipara), P.O- Rudra, PS. - Ranibandh, Dist. - Bankura after maintaining all legal formalities of arrest and NHRC guide lines. I along with forces checked him after maintaining his decency but nothing found.

Under the above, I pray to you to start a cog case under section 46 A (c) Bengal Excise Act against the accused persons namely 1) Bablu Bagdi (Male / Age Approx. 51 Yrs.) S/O Late Rakhahari Bagdi of Vill.- Rudra (Bagdipara), P.O- Rudra, PS. - Ranibandh, Dist. - Bankura and 2) Shaktipada Khan (Male / Age Approx. 59 Yrs.) S/O Late Radhagobinda Khan of Vill.- Rudra (Telipara), P.O - Rudra, PS. - Ranibandh, Dist. - Bankura.
