In producing herewith the following accd.persons namely 1) Suryamoni Murmu (Female / Age Approx. 37 Yrs.) W/O Girijal Murmu of Vill.-Bansole, P.O- Dhagara, PS. - Ranibandh, Dist. - Bankura and 2) Pani Baskey(Female / Age Approx. 40 Yrs.) W/O Pradip Baskey of Vill.- Tilaboni, PS- Khatra, Dist- Bankura along with seized supposedly **Total - approx. 60 (Sixty) Ltrs. improvised deshi liquor** in 03 (Three) container (Plastic Jariken) containing in each 20 (Twenty) Ltrs. in 3(Three)big Nylon bags and 32 (Thirty Two) plastic glasses.

I, ASI Buddhadeb Nandi of Ranibandh PS, would like to draw your kind attention to the fact that today on 23.11.2023 at 06.25 hrs. received a piece of information from my credible source that 02 (Two) person (names and particulars are noted above) have been transporting and selling I/D liquor in open place near Bansole village more under Ranibandh P.S, Dist.- Bankura illegally. People of Bansole, Sindurpur, Dhagara villages and other adjacent areas are coming there for consuming that I/D liquor and thereby making the area obnoxious. After that I informed the said information to the I/C, Ranibandh P.S and as per his direction noted in G.D vide Ranibandh P.S G.D.E No. 943 Date - 23.11.2023. As per his instruction, I left P.S for executing the said piece of information with forces C/ 1496 Madhu Das, C/1119 Rabindranath Murmu and LC-1794 Mousami Sinha Mahapatra for held raid vide Ranibandh PS C.C No. 2152/2023 , Dt. 23.11.2023. Around 06.45 Hrs., reached near Bansole village more under Ranibandh P.S, Dist.- Bankura. My source showed me that illegal liquor i.e 03 (Three) container (Plastic Jariken) containing in each 20 (Twenty) Ltrs. in 3(Three) big Nylon bags and 32 (Thirty) plastic glasses, in which containing supposedly approx. **60 (Sixty) Ltrs. improvised deshi liquor** on the both hands of the said accused persons besides a abandoned breakage Gumti. I along with my forces, cordoned off the place and found the aforesaid persons selling and transporting I/D liquor. On seeing Police both the said accused persons tried to fled away by left the said 03 (Three) container (Plastic Jariken) in 03 (Three) Nylon bags, containing supposedly approx. 60 (Sixty) Ltrs. improvised deshi liquor and 32 (Thirty Two) plastic glasses on the ground. On hot chased my accompanied lady constable apprehended the both the accused persons. I interrogated both the accused persons in presence of my accompanied lady constable without any threat and inducement after maintaining their decency as per Cr.P.C and NHRC guide line. On my interrogation the give their identity as 1) Suryamoni Murmu (Female / Age Approx. 37 Yrs.) W/O Girijal Murmu of Vill.-Bansole, P.O- Dhagara, PS. - Ranibandh, Dist. - Bankura and her accompanied as her elder sister 2) Pani Baskey(Female / Age Approx. 40 Yrs.) W/O Pradip Baskey of Vill.-Tilaboni, PS- Khatra, Dist- Bankura. I asked both the apprehended accused persons to show documents in support of selling and transporting I/D liquor. They failed to produce any documents. Thereafter, I seized supposedly **Total - approx. 60 (Sixty) Ltrs. improvised deshi liquor** in 03 (Three) container (Plastic Jariken) containing in each 20 (Twenty) Ltrs. in 3(Three)big Nylon bags and 32 (Thirty Two) plastic glasses (details in seizure list) under proper seizure list. As all the onlookers denied signing on seizure list, I took the signatures of my accompanying forces and the aforesaid apprehended accused person on the seizure list. Prepared labels. After that, by the help of my accompanied lady constable, at 07.45 hrs and 07.50 hrs. respectively, I arrested both the accused persons 1) Suryamoni Murmu (Female / Age Approx. 37 Yrs.) W/O Girijal Murmu of Vill.-Bansole, P.O- Dhagara, PS. - Ranibandh, Dist. - Bankura and 2) Pani Baskey(Female / Age Approx. 40 Yrs.) W/O Pradip Baskey of Vill.-Tilaboni, PS- Khatra, Dist- Bankura after maintaining all legal formalities of arrest and NHRC guide lines after maintain proper decency. I along with forces checked him after maintaining his decency but nothing found.

Under the above, I pray to you that start a cog case under section 46 A (c) Bengal Excise Act against the said accused persons.


