Dear Sir,

We would like to inform you that the vehicle no: WB-40AX-2146 owned by L&T company was handed over to Basudeb Das for use as per company norms.

On 23-11-2023 (Thursday) evening Basudeb Das went to Biharinath under Saltora Police Station, Bankura driving the said car no WB-40AX-2146 along with Basudev Das (54 years), Kasturi Das (50 years), Subrata Das (36 years), Priyanka Das (34 years) & Adriti Das (1.5 years) to attend a marriage party.

After attending the party, while they were returning to Durgapur from Biharinath at around **11:40 pm** the said car capsized on the roadside ditch near Pabra more under Saltora Police Station to save a street dog.

As a result, Basudeb Das who is driving the car no: WB-40AX-2146, Kasturi Das, Priyanka Das & Adriti Das sustained serious injuries on their persons. Mr. Subrata Das call to our colleague for immediate rescue and within 15 minute they came to the spot and shifted to Royal Care Nursing Home for treatment. Then they were shifted to Mission Hospital, Durgapur for better treatment. At present they are admitted to Mission Hospital with precarious condition. It is to note that Adriti Das (1.5 years) expired on the way to Nursing Home due to injuries and the car is badly damaged.

So, we request you please take necessary steps over the incident and oblige.
