Most respectfully I beg to state that today on 4 November 2023 I went to SBI ATM situated inside of the State Bank of India Khatra branch in connection to routine change my ATM password at about 12.30 afternoon. In that time one unknown man approached to me and offer help in changing the ATM password. I assumed he may be a helping staff of the Bank. So, I welcomed him. He was showing to help me and some how he changed my ATM card and inserted a fake ATM card instead. I couldn't notice that. After some time he left the place. So, I continued trying to change my ATM password.

Suddenly at 12.53 P.M and then at 12.54 P.M. and then at 12.56 I have received consecutively 3 messages to my mobile phone that @ Rs. 10,000.00 (ten thousand) Rs. 40,000.00 (forty thousand) withdrawn from my said Bank Account. I became spell bound and too much frustrated and running here and there in the Bank and immediately reported incident to the Bank Authorities. They informed me that the money withdrawn from the PNB ATM attached to PNB Khatra branch. I Requested to show me the CC TV recording to let me identify that cheater who offered me his help. But the Bank Authorities answered me that they cannot show me CC TV recordings. Yet they assured me to supply such CC TV recordings to the Police Officers if they ask for that.

In this regard may I request your good offices to please treat this letter as FIR and kindly do the needful in respect to the above facts. Please know that I will easily identify that cheater if you show me the CC TV recordings of the SBI Khatra branch and the PNB ATM attached to PNB Khatra branch.
