Suddenly at 12.53 P.M and then at 12.54 P.M. and then at 12.56 I have received consecutively 3 messages to my mobile phone that @ Rs. 10,000.00 (ten thousand) Rs. 40,000.00 (forty thousand) withdrawn from my said Bank Account. I became spell bound and too much frustrated and running here and there in the Bank and immediately reported incident to the Bank Authorities. They informed me that the money withdrawn from the SNB ATM attached to PNB Khatra branch. I Requested to show me the CC TV recording to let me identify that cheater who offered me his help. But the Bank Authorities answered me that they cannot show me CC TV recordings. Yet they assured me to supply such CC TV recordings to the Police Officers if they ask for that.

In this regard may I request your good offices to please treat this letter as FIR and kindly do the needful in respect to the above facts. Please know that I will easily identify that cheater if you show me the CC TV recordings of the SBI Khatra branch and the PNB ATM attached to PNB Khatra branch.
