Sir,

In producing herewith one seized vehicle bearing Regi no- WB27/0790 (12wheeler Truck), and one arrested accused namely Pradip Sarkar (55yrs) S/o- Lt Laxman Sarkar of vill- Palta, PO- Natungram, PS- Gopalnagar, Dist- North 24 Parganas, (Driver of the seized vehicle); I beg to state that I ASI Tapas Kr Dey of Bishnupur P.S. alongwith force were performing night patrolling duty in PS area, vide Bishnupur PS GDE no-1270, and CC no- 5409, dated 24.12.23. On 24.12.23 at about 19.30hrs, I got information that an accident is occurred near Harighat area, on Bishnupur-Joypur Road (SH-2). I informed the same to I/C Bishnupur P.S. and rushed to the spot to verify the incident.

On arrival at spot, near Harighat, we the police team saw that the accidentoccurred. One Road-roller was standing left side of the road due to some of its mechanical fault. Driver of the Road-Roller was checking it. At that time, one 12-wheeler loaded Truck bearing Regi no- WB27/0790, dashed the driver of the Road-Roller. Both the vehicles were on way towards Joypur side. The driver of Roller sustained injuries and, I, with the help of local people arrange to send the person to Bishnupur District Hospital. Thereafter, I seized the offending vehicle, and also arrested the accused driver as per procedure laid down in CrPC. After few hours of his admission, the driver of Road-roller is declared as dead.

Basic enquiry reveals that, the name of the victim driver is Tribeni Paswan (45yrs) S/o- Lt Babulal Paswan of vill- Andharpur, PS- Ghanashyampur, Dist-Dwarbhanga, State-Bihar. It is known that the accident occurred due to rash and negligent driving of the driver of the vehicle bearing Regi no- WB27/0790.

In this circumstance, I submitted a suo-moto complaint as first information report, before you to take necessary action as per law.
