Sub:- Lodging of F.I.R U/S 135(1) (b) of Electricity Act 2003 amended in 2007 against Accused Sumanta Nayak , S/O- Tapan Nayak , Vill.-Sihās , P.O. – Sihās , P.S- Kotulpur , Dist:- Bankura.

Dear sir,

I, Sri Madhab Chandra Kundu, S/O Aditya Kumar Kundu , A.E & Station Manager , Kotulpur Customer Care Centre, WBSEDCL being empowered by Electricity Act 2003 ammended in 2007 do hereby lodge a complaint against accused person Sumanta Nayak, S/O- Tapan Nayak, Vill-Sihās ,PO- Sihās , P.S- Kotulpur, Dist:- Bankura, for committing theft of electricity by way of making direct connection after removal of incoming service line from meter terminal point for the purpose of their Domestic use where One no. Live Domestic connection already exists bearing Con ID- 202782348 in the name of the accused Sumanta Nayak, which interferes the actual or proper registration of Meter.

On getting the source information of theft of electricity myself along with Biswajit Mandal, J.E(Gr-II) of Kotulpur CCC today 22.12.2023 between 12.00 to 12.20 hours inspected the premises of accused Sumanta Nayak, S/O- Tapan Nayak, Vill-Sihās ,PO- Sihās , P.S- Kotulpur, Dist:- Bankura.

During inspection it was detected that the said accused User was enjoying electricity unauthorizedly by way of direct connection after removal of incoming service line from meter terminal point for his Domestic purpose where One no. live Domestic connection already exist bearing Con ID- 202782348 in the name of the accused Sumanta Nayak. Thus the accused Sumanta Nayak , S/O- Tapan Nayak, Vill-Sihās ,PO- Sihās , P.S- Kotulpur, Dist:- Bankura violated the existing rules of Electricity Act 2003 (amended in 2007).

Inspection report prepared on the spot and assessed consumption of load which was detected as **700 Watt**. The details have been mentioned in the Inspection report.

I directed Biswajit Mandal, S/O- Shasanka Sekhar Mondal to remove the portion of direct connection cable and disconnect the Live Domestic Service Connection bearing Con _Id 202782348. Accordingly he disconnected the direct connection point & the existing service cable from service pole with the help of LT Mobile Van Staff of Kotulpur CCC, WBSEDCL as per direction. I sized the portion of the service cable for preparation of seizure list. I fixed up the responsibility to the accused user Sumanta Nayak, S/O- Tapan Nayak , Vill-Sihās ,PO- Sihās , P.S- Kotulpur, Dist:- Bankura with the help of my source , since the perpetrator was not present at the time of my inspection as well as detection of offence.

It is well proved that the said accused Users Sumanta Nayak, S/O- Tapan Nayak, Vill-Sihhas ,PO- Sihhas , P.S- Kotulpur, Dist:- Bankura , was committing the theft of electricity as he was using electricity unauthorizedly by way of making direct connection after removal of incoming service line from meter terminal point which interferes the actual or proper registration of Meter. As such he is liable for persecution U/S 135(1) (b) of Electricity Act 2003 (amended in 2007).
