Sub:- Prayer for lodging F.I.R. against drivers and owners of Seized (1) Tractor without registration number having Engine No.-NJD2EAJ0423 and Chassis No.-MBNABAEXPJJD01830,(2) Tractor bearing registration No.- WB-67A/9361 number having Engine No.-391354DP012524Aand Chassis No.-WVTA30428159722 and others.

Sir,

In producing herewith the Two seized sand loaded (1) Tractor without registration number having Engine no NJD2EAJ0423 and Chassis no MBNABAEXPJJD01830 (Model -B275 DI) with sand loaded trolley (Without Registration Number). (2) Tractor bearing registration No.- WB-67A/9361 number having Engine No.-391354DP012524 and Chassis No.-WVTA30428159722 (Model - Swraj735FE) with partially sand loaded trolley (Without umber). I beg to submit that today i.e., on 23.12.2023 as per information (vide GDE No.-1159 dt 23/12/2023) myself along with force left P.S vide Patrasayer P.S GDE No.-1168 and CC no 2219/2023 dated 23.12.202 to work out the information. We reached at Balarampur Dwarakeswar River Ghat at 09:05 hrs and found that two tractors were coming from river bed of Balarampur, on hat chased we managed to detain the above tractor bearing no Engine no NJD2EAJ0423 and Chassis no MBNABAEXPJJD01830 in a short distance but the driver fled away .On the other side seeing police party the other driver of the Tractor bearing no WB-67A/9361 unloaded his tractor Partially as the Tractor had hydrolic facility and fled away. During checking I found the vehicle was carrying sand. We asked the local people who are the actual owner and driver of said detain tractors. On local enquiry I also came to know that the driver of said Tractors along with owner and others deals with sand illegally in a clandestine manner. As the drivers of the said Tractors trolley loaded sand, it is crystal clear that they loaded the sand in the said trolley of the tractor by any fraudulent means after stealing it from Dwarakeswar river bed. They frequently were engaged in such type of act by clandestine manner in connivance with the owner of both tractors. On the above it is to be noted that there is no legal sand mining ghat at the said place i.e Balarampur from where the Tractors driver loaded the sand.

Under the above fact and circumstances in suspicion of stolen property I seized the above noted sand loaded two tractors in between 09:25 hrs to 10:25 hours. Request local people, but none turn up to sign in the seizure list, so my accompanying force signed in the seizure list.

I therefore pray before you that a specific case may kindly be started in this regard against the drivers and owners of above noted tractors (1)Tractor without registration number having Engine no NJD2EAJ0423 and Chassis No.-MBNABAEXPJJD01830 (Model -B275 DI) with sand loaded trolley (Without Registration Number). (2)Tractor bearing registration No.-WB-67A/9361 number having Engine No.-391354DP012524A and Chassis No.-WVTA30428159722 (Model - Swraj735FE) with sand loaded trolley (Without Registration Number with sand loaded trolley (Without Registration Number) and others under proper section of law and arranged for its investigation.
