Sub: FIR against theft of electricity

Sir,

I do hereby lodge my complaint empowered by the Electricity Act-2003 and its Amendment Act'2007 against KRISHNA BETAL, C/O- Banshi Betal residing at Vill- Niljora, PO- Motgoda, P.S-Raipur Dist-Bankura, for committing theft of electricity and thereby he is liable to prosecute U/S 135(1)(a) & (1)(b) of Electricity Act, 2003 (Amendment Act, 2007) as stated hereunder.

Today, i.e. on 12.12.2023 at 13:00 l, Najmul Hoda, DE & SM, S/O- Lt. MD. Muslim Tajir, Monoranjan Hazari (Linesman) S/O Banshi Hazari, Harisadhan Karmakar(Sr. TSH) S/O Lt. Indrajit Karmakar & Babula Mahato S/O- Arjun Mahato all of Raipur CCC along with Biplab Mandi,S&LP wing, &

Sankar Ch Dana, SO (s&lp), BNK RO inspected the commercial premises at Vill-Nilzora.

During inspection after serving proper notice at the commercial premises of KRISHNA BETAL at Vill- Niljora, PO- Motgoda, P.S-Raipur Dist-Bankura it was observed that he was consuming electricity dishonestly and unauthorizedly by bypassing the energy meter of WBSEDCL (Meter No. BE0450967) through direct hooking from nearest LTOH line of WBSEDCL for commercial purpose although his premises has one no. service connection bearing meter no: BE0450967 in the name of accused.

As theft of electricity was detected, I with the help of my staffs disconnected the service connection and dismantled some portion of single core two no 2.5 sqm copper wire used for direct hooking for bypassing the existing meter of multiple colour (White, yellow, green& red) of approx length 8mtr along with 2 pin plug & socket under a proper seizure list duly signed by our inspection team members.

The seized material was packed, labeled and sealed at the spot. Inspection team left the aforesaid

location at about 13:30 hrs after completion of all formalities.

So, accused KRISHNA BETAL, residing at Vill- Niljora, PO- Motgoda, P.S-Raipur Dist-Bankura, has committed an offence for which he is liable to prosecute U/S 135 (1)(a)(1)(b) of the Electricity Act 2003 and its Amendment Act 2007.

Hence you are requested to take cognizance of this complaint and to treat this as FIR.
