I do hereby lodge my complaint empowered by the Electricity Act-2003 and its Amendment Act'2007 against PRASANTA MONDAL, C/O- LAXMIKANTA MONDAL residing at Vill-Kumarara, PO- Satpatta, P.S-Raipur Dist-Bankura, for committing theft of electricity and thereby he is liable to prosecute U/S 135(1)(a) of Electricity Act, 2003 (Amendment Act, 2007) as stated hereunder.

Today, i.e. on 12.12.2023 at 15:00 I, Najmul Hoda, DE & SM, S/O- Lt. MD. Muslim Tajir, Monoranjan Hazari (Linesman) S/O Banshi Hazari, Harisadhan Karmakar(Sr. TSH) S/O Lt. Indrajit Karmakar & Babula Mahato S/O- Arjun Mahato all of Raipur CCC along with Biplab Mandi,S&LP wing, & Sankar Ch Dana, SO (s&lp),BNK RO inspected the commercial premises at Vill- Kumarara.

During inspection after serving proper notice at the commercial premises of PRASANTA MONDAL at Vill- Kumarara, PO- Satpatta, P.S-Raipur Dist-Bankura it was observed that he was consuming electricity dishonestly and unauthorizedly by way of direct hooking from nearest LTOH line of WBSEDCL for commercial purpose. Thus huge revenue of WBSEDCL lost.

As theft of electricity was detected, I with the help of my staffs disconnected the service connection and dismantled some portion of single core two no blue colored alluminium wire 3.5sqmm of approx length 4 mtr each under a proper seizure list duly signed by our inspection team members.

The seized material was packed, labeled and sealed at the spot. Inspection team left the aforesaid location at about 15:30 hrs after completion of all formalities.

So, accused PRASANTA MONDAL, residing at Vill- Kumarara, PO- Satpatta, P.S-Raipur Dist-Bankura, has committed an offence for which he is liable to prosecute U/S 135 (1)(a) of the Electricity Act 2003 and its Amendment Act 2007.

Hence you are requested to take cognizance of this complaint and to treat this as FIR.
