 Mr. Dinesh Kumar Das, 35 years old, residing
 at P.S. - Simlapal, Bankura, Bihar,
 was found dead in his house located at
 22-22-2023, Complainant's residence.
 According to the complainant, he had been
 sleeping in his bed when he suddenly
 heard a loud noise coming from outside.
 He got up and saw a black dog standing
 near his house. He tried to chase it away
 but the dog ran into his house and bit him
 on the leg. He tried to catch the dog but
 it ran away. He then went to the police
 station and reported the incident.
 The police conducted an investigation
 and found that the dog had been
 hit by a car earlier in the day.
 The dog was taken to a nearby hospital
 for treatment. The dog died due to
 multiple injuries.
