Sir.

I, Sri Suman Dhuya, s/o Lt Biman Baran Dhuya, AE & SM Taldangra CCC, WBSEDCL, Taldangra, Bankura being empowered by Electricity Act-2003 Amended in 2007 do hereby want to lodge complaint against namely Bhairab Patra, S/O. Sribas Patra @Bula of Village: Dhadanga, PS: Taldangra, Dist: Bankura who was committing theft of electricity by direct hooking from the nearby LTOH line of WBSEDCL for the electricity energy consumption for commercial purpose (Poultry Firm).

Following a secret source of information, on 13.12.2023 between 13:25 hours to 13:50 hours, I along with Biplab Mandi s/o Dharamdas Mandi, DE (E), S&LP and Sankar Chandra Dana s/o Lt. Rabindranath Dana, S.O. (S&LP) both of Bankura Regional Office, WBSEDCL, Sri Animesh Singha Mahapatra, Sr. TSH s/o Lt. Bikash Singha Mahapatra of Taldangra CCC and Sri Dilip Rajwar, Grade-I TSH s/o Lt. Nakul Rajwar of Taldangra CCC, WBSEDCL, Taldangra, Bankura inspected the commercial premises at Dhadanga, PO-Methana of the accused namely, Bhairab Patra, S/O. Sribas Patra @Bula of Village: Dhadanga, PS: Taldangra, Dist: Bankura and it was detected that the said accused person was committing theft of electricity by direct hooking from the nearby LTOH line of WBSEDCL for the electricity energy consumption for commercial purpose (Poultry Firm).

The Load assessed as 0.72 KW by the inspection team and accordingly the inspection report was prepared on the spot. Then I instructed Sri Dilip Rajwar, Grade-I TSH to dehook the hooking line from the nearest LTOH line of WBSEDCL and he did as the same he was instructed. I prepared the seizure list on the spot of inspection.

Copy of inspection report and Seizure List prepared could not be handed over the accused person for his absence on the spot as well as for the cause of unwillingness of his representatives.

It is well proved that the accused person committed the theft of electricity with two core PVC cable with length about 06 meter for direct hooking from the nearest LT Overhead line to consume electricity for his commercial purpose.

As such, he is liable for prosecution with U/S 135 (i) (a) Electricity Act-2003 Amended in 2007.
