Sub:- Prayer for lodging FIR.

Sir,

In producing here with one arrested accused person namely Lakhan Murmu (19 yrs.) s/o- Naresh Murmu of village Dhulabad PS -Puncha, dist Purulia with one seized Black colour Hero Super Spelender motor cycle without number plate having chassis no - MBL JAW173L9F53440 and Engine no, JA07ABL9F24126, I SI Shambhunath Banerjee of Taldangra PS lodged a written complaint as suo-moto that on 01.12.23 at 14.05 hrs. during my mobile duty, I received a secret source information that one person came from Parirdihi village side with one stolen Motor Cycle. Then I inform the matter to I.C Taldangra PS and as per his direction I along with force placed NAKA at Parirdihi-Rakhaban village More under Taldangra PS vide Amdangra OP under Taldangra PS GDE No. 13 and CC No. 863/23 dtd. 01.12.23.

During NAKA Checking, we found that one motorcycle was coming towards Rakhaban village side. Accordingly we tried to stop him by giving signal, but seeing police he tried to fled away but we managed to apprehend him with the help of public. During apprehension he was slightly manhandled by the public. Accordingly he received some injuries on his persons and he was treated medically. I interrogate the apprehended person and on interrogation he disclosed his identity as noted above and he also disclose he came at his relative house at Paridihi village. On asked, about his Motor Cycle, he failed to produced any documents in respect of the said Motor Cycle . During interrogation he confessed that the said Motor Cycle he stolen away from Arambag side and now he tried to sale said stolen Motor Cycle at that area. So, I seized the said motor cycle without number plate having chassis no - MBL JAW173L9F53440 and Engine no, JA07ABL9F24126 under proper seizure list duly signed by the witnesses. There after I arrested him maintaining the NHRC guidelines and the directions of Hon'ble Apex Court. I informed him the grounds of his arrest and supplied the copies of memo of arrest to him duly acknowledge by him. Accordingly I brought him at Taldangra PS after proper medical check-up and proper escort.

Under the above fact and circumstances I therefore pray that a specific case U/S-379/411/414, may kindly be started against the above noted arrested accused person and obliged.
