Respected sir,

This is to inform you that, I, Mangaldip sarkar, S/O Late Purnendu Bikash Sarkar (63yrs), presently residing at Vill-Raniara, P.O.-Vedua, P.S.-Simlapal, Dist.-Bankura, at present residing at Panchmura 77 para under P.S. Taldangra, hereby inform you that on 11/12/2023 at about 5:00 to 5:30 p.m my father Late was having evening walk through the extreme left side of Taldangra-Bishnupur Road, suddenly one motor Cycle Vide no WB 40AN/7910 came at a very high speed and suddenly lost control and dashed the victim from back side in very rash and negligent manner. The incident occurred near Rupsha hardware store Panchmura. As consequences my father fell down blood shade and died on spot.

Local people took him to Taldangra Rural Hospital where he declared dead by the attending doctors.

After that Post Mortem done by M.O. of Bankura Sammalani Medical College and Hospital, vide P.M. No 1358/2023 dt. 12/12/2023 against one U/D case has been initiated vide Taldangra P.S. U/D case no 34/23 dated 11/12/23,

The accident was caused due to the rash and negligent driving on the part of the rider of the offending Motor Cycle bearing no. WB 40AN/7910

You are requested to take strong necessary action against rider of the Motor Cycle vide no: WB 40AN/7910, as we were busy in funeral ceremony of my father we could not able to lodge the FIR in proper time.

Please take necessary action.
