Sub: Complaint against the arrested accused persons namely 1) Rajesh Chowdhury (19 Yrs) S/O-Rabilochan Chowdhury 2) Rabilochan Chowdhury S/O- Anath Chowdhury both of Vill.- Ladna, PO- Mankanali PS & Dist.- Bankura owner of the Puja Hindu Hotel, Near Tilabedia More, under PS & Dist- Bankura for lodging FIR against them.

Sir,

In producing herewith, the arrested accused persons namely Rajesh Chowdhury S/O-Rabilochan Chowdhury of Vill.- Ladna, PO- Mankanali-PS & Dist.- Bankura along with seized articles i.e. 24 bottle of liquor style as CAPTAIN in which value of Rs. (24X155/-) total value Rs. 3720/-. I beg to report that today i.e. on 14.01.2024 at 19:55 hrs, I ASI Khitish Ch. Gorai of Bankura PS during my mobile duty received a secret and credible source information that two persons were selling ID liquor at Puja Hindu Hotel situated beside Mejia- Bankura National highway near Tilabedia More, under PS & Dist.- Bankura without any valid license. Over this source information, I along with force had been to Puja Hindu Hotel at 20:15 hrs to work out the information. I along with force surrounded the PO & found that said Rajesh Chowdhury and Rabilochan Chowdhury were selling liquor at Puja Hindu Hotel and some persons were purchased liquor from them. I along with force held raid. But on seeing Police party one Rabilochan Chowdhury and all purchasers fled away but we are able to apprehend one Rajesh Chowdhury who sold liquor with Rabilochan Chowdhury (owner of the said hotel). I asked him to produce valid license for selling liquor but he failed to produce any valid document. I asked him about his identity & he disclosed his identity as, Rajesh Chowdhury (19 Yrs) S/O- Rabilochan Chowdhury of Vill.- Ladna, PO- Mankanali PS & Dist.- Bankura he also disclosed his father identity as Rabilochan Chowdhury S/O- Anath Chowdhury of Vill.- Ladna, PO- Mankanali PS & Dist.-Bankura (owner of the Puja Hindu Hotel, under PS & Dist- Bankura. So, I arrested him at 20:35 hrs after observing all the legal formalities. I explained him about the ground of arrest and I seized 24 bottle of liquor style as CAPTAIN in which value of Rs. (24X155/-) total value Rs. 3720/under proper seizure list duly signed by the Police witness as no public witnesses was available there. Labeled the same. I collected 500 ml ID liquor from said bottle in a separate plastic bottle as sample and sealed with gala.

Under the above circumstances, I pray before you that a specific case may kindly be registered against the accused persons namely 1) Rajesh Chowdhury (19 Yrs) S/O- Rabilochan Chowdhury 2) Rabilochan Chowdhury S/O- Lt. Anath Chowdhury both of Vill.- Ladna, PO-Mankanali PS & Dist.- Bankura owner of the Puja Hindu Hotel, Near Tilabedia More, under PS & Dist- Bankura under proper section of Law.
