Subject: Urgent complaint regarding threats and Harassment.


Respected Sir,

I hope this letter finds you well. I am writing to bring your attention a serious matter that occurred on Jan 5, 2024, at midnight around 12:30 am. My mother (Mita Nandi) and my sister (Moudisa Nandi) were subjected to threats and harassment by a group of Individuals. (One's name is Milton and other's is Moni).

My mother witnessed an act of animal cruelty where a labour involved in the construction of a flat in front of my house beat a dog badly. Upon seeing this inhumane act, my mother protested against the brutality. Unfortunately, this led to threats directed towards her and also from some individuals associated with the construction site.

Given the severity of the situation, we believe it is crucial to report this incident promptly. We request your assistance in investigating this matter to ensure justice is served and to safeguard our family from any potential harm.
