That being a widow somehow, I have collected One Lakh from my salaries months by months and intended to deposit the said One Lakh as Fixed Deposit for future benefit.

That on behalf of the society one Partha Karmakar S/o Nimai Karmakar of village Belboni P.O. Narrah P.S+ Dist. Bankura who is a process server in Bankura Judgeship is appointed for Collector of money from the intended depositor on behalf of the said depositor.

That on **November** I have deposited Rupees One Lakh to said Partha Karmakar and after receiving the same Partha Karmakar directed me to sign on the Monthly Register of Debit and Credit of money of the Society. At the relevant point of time another employee of our District Court was also present. Though I have deposited the amount of One Lakh for Fixed Deposit to Parth Karmakar who in the sole In- Charge of Transaction of Money on behalf of the said Society neither issued any Receipt of Payment nor any Folio in favour of your Petitioner.

On **18/12/2023** when I demand for the Receipt of Payment or the Folio of my deposit of One Lakh as Fixed Deposit in the credit society, at that time Partha Karmakar replied and assured over telephone that he would issue both the document as early as possible and then after some time he totally denied the fact that I gave him two bundle of 500 Rs note and Sandha Nag in whose presence transaction of One Lakh was done was called over cell phone, she also admitted that entire transaction has been made in cash to Partha Karmakar such conversation in between me and Sandha Nag is recorded in my Cell Phone and that call recording shall have to be produce before any authority at any point of time for proper verification of Law.

That from the conduct of the Partha Karmakar it has been established that he has deceived me being a helpless widow and misappropriated the money for his illegal gain.

There after I repeatedly tried to submit a written complaint to the Inspector In-Charge of Bankura Police Station, Bankura (W.B) with a prayer for adequate action against Partha Karmakar as per Law. The written complaint was placed before S.I. of Police Salil Kumar Pal of Bankura P.S of West Bengal but very unfortunate to state here that S.I Salil Kumar Pal or Debasis Panda Inspector In-Charge Bankura Police

Finding no alternative, I have to knock at your door for proper steps whereby a widow woman has been cheated and misappropriated the amount of Rupees One Lakh which I saved somehow for her future benefit but all my prayer is turned to futile and beg excuse to disturbing your valuable time.

Hope that the matter will be looked into with great sympathy for the purpose of recovery of the amount or to direct the Police authority to start a case against Sri Partha Karmakar as per law who has deliberately commit the offences.
