Sub:- Prayer for starting a specific case.

Sir,

In producing here with one accused person named Alauddin Molla (31yrs), S/O- Mozam Molla of Swrup Nagar, Shyam Nagar, PS-Kashipur, Kolkata- 135 under arrest and seized one truck bearing registration no WB 61B 6287 loaded with sand and original seizure list enclosed here with.

I do here by lodge this complaint regarding that today (on 04.01.2024) evening at about 19:25 hrs during area patrolling duty Vide Radhanagar Out Post C.C. No-08/2024 date-04.01.24 and GDE No-93 Date-04.01.2024 received secret source information that one sand loaded truck bearing registration no WB 61B 6287 was coming towards Joykrishnapur village from Ajodha village side under Bishnupur P.S loaded with sand without proper challan or valid document. Accordingly, after obtaining kind order of I.C. Bishnupur P.S, I along with force went towards Joykrishnapur village and on the way near Joykrishnapur bazar under Bishnupur PS area found the above noted sand loaded truck was coming towards Joykrishnapur bazar. Seeing the Police van, the driver of the truck stopped the vehicle and started to flee away leaving behind the truck on the road. I along with accompanied force in suspicion chased him, and could apprehend the driver named Alauddin Molla. I interrogated the accused driver and came to learn that he is the driver of sand loaded truck bearing registration no WB 61B 6287. On demand he could produce neither any challan nor valid document nor could give any satisfactory answer in respect of the sand loaded truck.

He often gave incoherent statements as sometimes stated that he loaded the sand from Charabottala Bali Ghat and sometimes stated that loaded the sand from Natunbazar Bali Ghat under Bishnupur PS. I also came to learn that some truck owners are involved in operating the process of illegal sand loading.

From the statement it is revealed that the owner along with the driver of the vehicle, Alauddin Molla (31yrs), S/O- Mozam Molla of Swrup Nagar, Shyamnagar, PS-Kashipur, Kolkata- 135, operating/transporting/selling this illegal business since long in clandestine manner.



Under the above fact & circumstances, in suspicion of stolen property, I seized the above noted sand loaded truck bearing registration no WB 61B 6287 in between 19.55 hrs to 20:05 hrs on 04.01.2024 under proper seizure list. I tried the local to sign in the seizure list but none came forward. As such, I took signature of my accompanied force on the seizure list as seizure witnesses.

I also arrested the accused driver named Alauddin Molla (31yrs), S/O- Mozam Molla of Swrup Nagar, Shyam Nagar, PS-Kashipur, Kolkata- 135 after maintaining all legal formalities prescribed by Apex Court and NHRC guide line under Memo of Arrest.

Accordingly, I brought him to Bishnupur PS after keeping the seized vehicle at Radhanagar OP, submitted complaint as sou-moto to this PS.

Under the above fact on study of circumstances it is evidently established that the above noted accused persons (Owner and Driver of the truck) have virtually committed offence punishable u/s- 379/411 I.P.C. and section 21 M.M.D.R. Act.
