Sub:- Prayer for lodging specific case

Sir.

In producing herewith two seized vehicles bearing Regi no- WB53C/5817 (16-wheeler Dumper), and Regi no- WB33A/1259 (Passenger Bus), I beg to state that I SI Chandan Paul along with force were performing high way patrolling duty in PS area, vide Bishnupur PS GDE no-573, and CC no- 250/24, dated 12.01.24. On 13.01.24 at about 07.55hrs, I got information that an accident occurred near Peardoba road, proceeding through Chowbeta to Sabrakone Road, in between two vehicles. After that, I informed the same to I/C Bishnupur P.S., and rushed to the spot.

On arrival at spot, near Peardoba, at around 08.15hrs we the police team saw that the accident, occurred in between the 16-wheeler Dumper (WB53C/5817) and one Bus (Shib Shakti) (WB33A/1259). None of the driver of the vehicles were present at spot. Few passengers of the Bus got injury. Among the injured persons, one person namely Kanaklata Shil (50yrs) W/o- Susanta Shil of Taldangra P.S. area received serious head injury, and was shifted to nearby Kaniska Hospital by locals. I with my accompanied force managed to clear the road with the help of recovery van, and seized the same subsequently, in between 08.45 hrs to 09.15hrs.

Preliminary enquiry reveals that, the Dumper was proceeding towards Bishnupur side from Sabrakone side, and the Bus was in opposite direction. Both of the vehicles were in excess speed, and do not take any precautionary measure in the curve road there. The incident occurred due to rash and negligent driving of the drivers of both the vehicle. To find out the actual cause of accident, proper investigation is required.

In this circumstance, I submitted a suo-moto complaint as first information report, before you to take necessary action as per law.
