I ASI Durydahan Maji of Bishnupur PS beg to state that today on 06.01.24 at about 12.55 hrs while performing my day mobile patrolling duty as per a telephonic information myself along with my force went to the backside of the abandoned house of one Lt Amarnath Kaity near Station Road Lakshimela. After reaching to the spot we found three (03) bags are lying in a bush & a person is trying to conceal himself in the bush. I have spotted the person & started to interrogate him. In course of interrogation he disclosed his identity as above mentioned & informed that he had stolen these bags containing articles of brass, bronze, kansa etc metal from that abandoned house. Accordingly I have arrested him after maintaining all sorts of formalities & seized the articles of those bags after preparing proper seizure list. In course of seizure procedure, I have asked the locals to sign in the seizure list as witnesses but they denied & hence finding no other alternatives I have taken the signature of my accompanying force in the seizure list. In course of further interrogation he informed that he collected used plastic bottles from different places & a few days ago he noticed these abandoned house. Today he entered the house & stolen these articles but he got caught red-handed.

Therefore, I am submitting this prayer before you to register specific case under proper section of law in this regard.
