Sir,

In producing herewith one arrested accused person namely Kartick Mal S/O- Madhu Mal of vill- Murllu, PS - Saltora, Dist- Bankura, along with one seized new tractor vide registration no -WB-81/0912 with sand loaded in trolley. The fact of the case in brief is that today (24.01.24) at 16:25 hrs received a suo moto complainant from ASI Buddhadeb Mukherjee of Jhantipahari OP under Chhatna PS to the effect that today [24.01.24] at about 14:05 hrs he received source information regarding illegal transportation of sand from Saltora - Dhaban village under Chhatna PS vide Jhantipahari OP under Chhatna PS GDE No - 523, date - 24.01.24 and I along with force left Jhantipahari OP in search of the said tractor Jhantipahari OP under Chhatna PS C.C No - 37/24, date - 24.01.24. When I reached at Dhaban Kendtol more under Chhatna PS at about 14:45 hrs he found one tractor bearing registration number- WB-81/0912 sand loaded in the trolley coming from Saltora side to Dhaban village side violating the govt. order. I stopped the said tractor and asked the driver of the tractor to produce any valid documents regarding transportation and ownership of the loaded sand in trolley of the tractor. The driver failed to produce any legal documents in this respects. In several times he gave different type of statements about the source of the sands and also revealed that he was directed by the owner of the said tractor WB-81/0912. During interrogation he suddenly jumped from the tractor and tried to flee from the spot. Somehow I along with forces managed to apprehend tractor driver. On interrogation the driver disclosed his identity as Kartik Mal s/o Madhu Mal of vill- Murllu, ps- Saltora, dist- Bankura. Accordingly I arrested him after maintaining all legal formalities regarding arrest. It is crystal clear that the driver has loaded sand in his tractor by fraudulent means after stealing the same and transporting it different places for its concealment to hoard it at secret places. I also stated that they have been dealing with stealing sand from different areas and selling it to different places for their personal gains and causing huge loss to the Govt. So, I seized the aforesaid Tractor vide registration No- WB-81/0912 loaded with sand in trolley under proper seizure list. The sand loaded tractor has been kept at Jhantipahari OP compound.

So, I pray before you to lodge a specific case against the said accused driver and owner of said tractor, as per specific section of law.
