Dear sir,

I, Sri Madhab Chandra Kundu, S/O Aditya Kumar Kundu , A.E & Station Manager , Kotulpur Customer Care Centre, WBSEDCL being empowered by Electricity Act 2003 ammended in 2007 do hereby lodge a complaint against accused person Aisan Ali Khan , S/O- Raham Ali Khan , Vill.- Nandagram, PO - Gopinathpur , P.S- Kotulpur, Dist:- Bankura, for committing theft of electricity by way of making loop connection from existing three nos single core PVC service cable for the purpose of their Agriculture use where One no. Live Agriculture connection already exists bearing Con ID- 233196718 in the name of the accused Aisan Ali Khan, which interferes the actual or proper registration of Meter.

On getting the source information of theft of electricity myself along with Biswajit Mandal , J.E(Gr-II) & Gautam Kr Dolui, Gr-I T.S.H of Kotulpur CCC & Sri Biplab Mandi , D.E , S & LP & Sri Sankar Ch Dana , Special Officer , S & LP, Bankura Region Office today 08.01.2024 between 15:00 to 15:20 hours inspected the agriculture premises of accused person Aisan Ali Khan , S/O- Raham Ali Khan , Vill.- Nandagram, PO - Gopinathpur , P.S- Kotulpur, Dist:- Bankura .

During inspection it was detected that the said accused User was enjoying electricity unauthorizedly by way of loop connection from existing three nos single core PVC service cable for his Agriculture purpose where One no. live Agriculture connection already exist bearing Con ID- 233196718 in the name of the accused Aisan Ali Khan. Thus the accused Aisan Ali Khan , S/O- Raham Ali Khan , Vill.- Nandagram, PO - Gopinathpur , P.S- Kotulpur, Dist:- Bankura violated the existing rules of Electricity Act 2003 (amended in 2007).

Inspection report prepared on the spot and assessed consumption of load which was detected as 3.73 KW.The details have mentioned in the Inspection report.

I directed Gautam Kr Dolui , S/O- Lt Probhas Dolui to remove the portion of service cable and disconnect the Live Domestic Service Connection bearing Con \_id 233196718. Accordingly he disconnected the PVC cable from the L.T.O.H line as per direction. I seized the portion of the service cable for preparation of seizure list from where he tapped. I fixed up the responsibility to the accused user Aisan Ali Khan , S/O- Raham Ali Khan , Vill.- Nandagram, PO - Gopinathpur , P.S- Kotulpur, Dist:- Bankura with the help of my source , since the perpetrator was not present at the time of my inspection as well as detection of offence.
