Sub:- Prayer for lodging FIR against Malay Chandan Kundu (approx. 51 Years), S/O- Late Bamkim Chandra Kundu of Village-Japamali, P.S- Mejia, District- Bankura.

Sir,

In producing herewith the arrested accused person namely Malay Chandan Kundu (approx. 51 Years), S/O- Late Bamkim Chandra Kundu of Village-Japamali, P.S- Mejia, District- Bankura along with seized articles (1) Four (04) bottles of Country Spirit styled as Captain 60° UP containing 600 ml each, MRP- RS 155/- per bottle, (2) One bottle of Country Spirit styled as Captain 60° UP containing 600 ml, MRP- RS 155/- collected as sample from SL No- 1 and duly sealed and labeled by me, I, ASI/1495-Goutam Roy of Mejia P.S do hereby lodge complaint against one Malay Chandan Kundu (approx. 51 Years), S/O- Late Bamkim Chandra Kundu of Village-Japamali, P.S- Mejia, District- Bankura to the effect that today on 25.01.2024 at about 14:45 hours in course of my mobile duty vide Mejia P.S G.D.E. no-1049 Dt - 25.01.2024 & C.C No- 265, received secret source information over phone that illegal sale of Country Spirit is going on near Japamali More adjacent area. Accordingly, I informed the matter to O/C, Mejia P.S over phone and as per his kind permission, I along with my accompanying force namely C/1305-Amar Nath Rajjak, NVF/0466- Rajib Chakraborty & NVF/478 Lalchand Duley left for Japamali more adjacent area to work out the information.

On 25.01.2024 at about 15:35 hours, I along with my accompanying force reached near Japamali more adjacent area. While we proceeding to the Japamali More adjacent Neem Tola area, seeing Police from a distance, some persons who were sitting in that place and taking liquor from Malay Chandan Kundu started to flee away. We chased them, but we could manage to detain one person. On being asked, he disclosed his identity as Malay Chandan Kundu (approx. 51 Years), S/O- Late Bamkim Chandra Kundu of Village-Japamali, P.S- Mejia, District- Bankura. I called some disinterested persons. In presence of some local people and police personnel searched the detained person and found Four (04) bottles of Country Spirit styled as Captain 60° UP containing 600 ml each, MRP- RS 155/- per bottle. On local enquiry, I came to learn that the apprehended person used to sell liquor illegally from that place and he is running this illegal business since long with a view to his wrongful gain. I arranged to collect one bottle as sample and sealed, labeled and seized the same in presence of witnesses. On several request, no local people came forward to sign the seizure list. Hence, finding no other alternatives, I took signature of my accompanying force namely C/1305-Amar Nath Rajjak, NVF/0466- Rajib Chakraborty & NVF/478 Lalchand Duley all of Mejia P.S on the seizure list as seizure witnesses. The seizure of the above articles was made in between 15:45 to 16.15 hrs in presence and duly signed by the accused person. On being asked, neither he nor any one in favour of him came forward to produce any license or valid document against his illegal sale of Country spirit. Accordingly, I arrested the accused person namely Malay Chandan Kundu (approx. 51 Years), S/O- Late Bamkim Chandra Kundu of Village-Japamali, P.S- Mejia, District- Bankura. The approximate value of the article seized is Rs. 620/- only.

I, therefore, pray before your kind self that a specific case may kindly be registered against the accused person namely Malay Chandan Kundu (approx. 51 Years), S/O- Late Bamkim Chandra Kundu of Village-Japamali, P.S- Mejia, District- Bankura under proper section of law and arrange for its investigation.
