Respected Sir,

In producing herewith one (01) arrested accused person namely Khokan Sekh (Aged approx 50 Years), S/O- Lt Aktar Sekh of Vill+P.S-Galsi, Dist- Purba Bardhaman, the driver of the seized Vehicle having tampered number plate (WB41K-0358), Engine no-NHPZ118651 & Chassis no-MB1NECHD3NPHS3707 laden with sand, along with Memo of Arrest and seizure list. I, SI Pradip Kr Mondal of Mejia P.S, do hereby lodge complaint to the effect that in course of special mobile duty on 25.01.2024 vide Mejia P.S GDE No- 1059 dtd-25.01.2024 and C.C No- 266 dtd. 25.01.2024, I received information from reliable source at 16:55 hours that illegal transportation of sand has been going on from Bhului -Kalidaspur road under Mejia PS. On getting such information, I informed the matter to OC Mejia PS and after getting his permission over phone, I along with accompanying force reached at Kalidaspur More to work out the information. On arrival, I found that one sand laden vehicle (WB41K-0358) was coming towards Mejia-Saltora road. On seeing the Police team in uniform, Chassis driver of the Vehicle bearing Engine no-NHPZ118651 MB1NECHD3NPHS3707 tried to flee away from the spot with his Sand laden vehicle. After a hot chase, we managed to apprehend him. On being asked to produce valid documents/challan in respect of vehicle laden with the sand, the driver produced one Echallan in respect of the vehicle. Then I, asked for document of the said Vehicle laden with sand. In response he produced one R/C of the vehicle, but the number WB41K-0367 mentioned in the R/C was not matched with the number plate of the vehicle and with the Echallan in respect of the sand. Accordingly I checked engine Number & the Chassis no of the vehicle with the R/C Book. Thereby it was clear, that the number plate was tampered and the E-challan was of the tampered number plate. Accordingly, I seized the said Vehicle, laden with sand, E-challan and the R/C Book under proper seizure list duly signed by the accused driver and witnesses. Hence, I arrested the accused driver of the Vehicle. On interrogation, he confessed his guilt and his direct involvement in this case. During online checking through WBMDTCL portal, I also found some pervious E-challans which were generated in respect of this tampered vehicle number for illegal transportation of sand.

I, therefore, pray before your kind self that a specific case may kindly be registered against the arrested accused driver of bearing tampered number plate vehicle(WB41K-0358), Engine no- NHPZ118651 & Chassis no-MB1NECHD3NPHS3707 laden with sand, and the owner of tampered number plate Vehicle (WB41K-0358), bearing Engine no- NHPZ118651 & Chassis no-MB1NECHD3NPHS3707 and arrange for its investigation.
