**Sub: - Complaint against Joginda Mondal (30) S/O Dhiren Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura**

Sir,

In producing herewith the arrested accused namely Joginda Mondal (30) S/O Dhiren Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura along with seized articles i.e. i) 10 (Ten) bottles of sealed country sprit styled as "CAPTAIN" measuring 600 ml each bottles (600 ml X 10 bottles=6.0 Itrs. MRP Rs- 150/- each bottle total RS- 1500), in which one 01 (one) Bottle collected as sample. I beg to submit that on 24/01/2024 at about 19:05 hrs when myself along with C/2698 Dharmaraj Ghosh ,C/ 698 Samir Mondal , NVF Rupam Das were performing evening mobile duty vide Saltora PS C.C No. 254/24 dtd 25.01.2024 then I received a credible source of information that one Joginda Mondal (30) S/O Dhiren Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura is involved in selling country sprit from his Joginda Dhaba near Mondal Weight bridge at Krishnapur village under Saltora P.S, Dist.-Bankura without any valid license. Accordingly I informed the matter to O/C Saltora PS and as per order of O/C Saltora PS, I along with accompanying force left for Krishnapur village area, under Saltora P.S to work out the information. Thereafter we reached at Krishnapur village area and found that some persons who were sitting back side of the Dhaba of said accd person. Seeing the Police vehicle they started to flee away. We chased behind them but all of them managed to escaped only we apprehended Seller person namely Joginda Mondal (30) S/O Dhiren Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura.

I along with force in between 19:25 to 19:55 hrs searched into the Dhaba of accd person and found approx 10 (Ten) bottles of sealed country sprit styled as "CAPTAIN" measuring 600 ml each bottles (600 ml X 10 bottles=6.0 Itrs. MRP Rs- 150/- each bottle total RS- 1500), in which one 01 (one) Bottle collected as sample. As the accd person illegally selling country sprit from his Joginda Dhaba near Mondal Weight bridge at Krishnapur village under Saltora P.S to customers with exchange of money for wrongful gain and he is running this illegal business since long. So I seized above noted articles after preparing proper seizure list duly signed by the police witnesses as no public witnesses agree to signed the S/L. I collected sample from the above and sealed and labeled in presence of police party which is duly signed by them. Then I arrested the accused at 20:05 hrs after observing all legal formalities laid down in Cr.P.C and Hon'ble Apex Court.

I therefore pray that a specific case under Bengal Excise Act may kindly be started against accused person namely Joginda Mondal (30) S/O Dhiren Mondal of Vill.- Kharbona, P.S.- Saltora, Dist- Bankura and arrange for its investigation.
