**Sub:** Lodging of FIR against GOUTAM MANDAL, S/O- Lt. Achyutananda Mandal of VILL+P.O-BASUDEBPUR, P.S- Sarenga, Dist.- Bankura for theft of electricity u/s 135(1)(a) of The Electricity Act 2003 (Amendment 2007).

Dear Sir,

In producing herewith the following article 1. One two core PVC Cable of approximate length 02 (two) meters along with Hooking arrangements seized under proper seizure list, duly signed by available witnesses I, Mr. Shouvik Malik, S/O- Mr. Bikash Malik, Assistant Engineer (E) & Station Manager, Sarenga Customer Care Centre, WBSEDCL, Sarenga, Bankura do hereby lodge complaint against one GOUTAM MANDAL, S/O- Lt. Achyutananda Mandal of VILL+P.O-BASUDEBPUR, P.S- Sarenga, Dist.- Bankura, to the effect that yesterday (i.e on 18/01/2024) acting on a tip-off, myself along with, Sri. Anjan Mahata, S/O- Nabakumar Mahata, J.E(E) & Sri. Tanmoy Kumbhakar, S/O- Sri Jaladhar Kumbhakar, Sr. TSH, of Sarenga CCC, WBSEDCL went to the location at Basudebpur village to work out on one source information. Around 1:30 pm of 18/01/2024 we reached at Basudebpur village and started inspecting the electric lines and Transformer near the domestic premise of the occupier GOUTAM MANDAL located at above mentioned village and during inspection the user GOUTAM MANDAL found stealing electricity dishonestly at his domestic premise by direct hooking from nearest LT over head line of WBSEDCL and has caused financial loss to WBSEDCL. The load is assessed to be 800 watts during preparing inspection report at the spot. The user was present there and not signed in the inspection report sheet. On asked the User cum occupier failed to give satisfactory reason for such action.

Thus the User GOUTAM MANDAL has violated the rules and provision of section 135(1)(a) The Electricity Act 2003 (Amendment 2007).

Hence I seized the above noted article under proper seizure list duly not signed by the user and available witnesses following disconnection of the unauthorized electric line by removing the hooking devices and producing before you with a request to initiate a cause u/s 135(1) (a) of The Electricity Act 2003 (Amendment 2007) against GOUTAM MANDAL, S/O- Lt. Achyutananda Mandal of VILL+P.O-BASUDEBPUR, P.S- Sarenga, Dist.- Bankura and arrange for its investigation. It is also to be mentioned that some local villagers were present there but they refused to sign as local witness in the seizure list and Inspection Report. It is also to be mentioned that we disconnected the unauthorized connection at that premise and left the premise at about 2:00 pm on the same day.
