Dear Sir,

This is to inform you that on receiving information from Beliatore P.S. on dated 27.01.2024 at about 05.30 AM regarding the accident occurred at Murakata, Chhandar under Beliatore C.C.C by the lorry vide Vehicle No:-WB25H1084 , we sent our technical team immediately to the spot to look into the matter and taking necessary action. During inspection by the u/s and others technical staff it was found that the said lorry had damaged two nos 8 mt PCC pole along with others accessories of LT network. Due to this accident WBSEDCL has lost its property which comes to the tune of Rs 48480.00 approx.

The estimate for damage cost has been handed over to the owner of the vehicle and he committed to deposit the same and was requested to allow two working days for deposition of damage cost but till now it seems the owner of the vehicle did not pay any heed to deposit the same by receiving quotation. This is the cause of delay to lodge formal complain before you.

Under these circumstances you are requested for taking necessary legal action as per norms.
