Sub: Complaint against the arrested accused person, Mrinal Bit (36 Yrs) S/O- Bangshi Bit of Katjuridanga, Dinabandhupally, PS & Dist.- Bankura for lodging FIR against him.

Sir,

In producing herewith, the arrested accused person namely Mrinal Bit (36 Yrs) S/O- Bangshi Bit of Katjuridanga, Dinabandhupally, PS & Dist.- Bankura along with seized articles i.e. (1) 35 bottles of ID liquor style as Dil Khush contained 375 ml each in which value of (35X35/- = 1225/-) (2) 25 litres ID liquor in 11 plastic bottle (each bottle contained 2 litres) in which value of (25X140= Rs. 3500 /-), I beg to report that today i.e. on 16.02.2024 at 19:05 hrs, I LSI Madhuri Roy of Bankura PS during my mobile duty received a secret and credible source information that one person was selling ID liquor at vacant place near Gobindanagar Bus Stand under PS & Dist.- Bankura without any valid license. Over this source information, myself along with force had been to near Gobindanagar Bus Stand at 19:20 hrs to work out the information. I along with force surrounded the PO & found that one person was selling ID liquor and some persons were purchased ID liquor from him. I along with force held raid, but on seeing Police team some persons who were purchased ID liquor succeed to fled away but we are able to apprehended the person who was selling ID liquor. I asked him to produce valid license for selling ID liquor but he failed to produce any valid document. I asked him about his identity & he disclosed his identity as, Mrinal Bit (36 Yrs) S/O- Bangshi Bit of Katjuridanga, Dinabandhupally, PS & Dist.- Bankura. So, I arrested him after observing all the legal formalities of arrest. I explained him about the ~~status~~ of arrest and seized (1) 35 bottles of ID liquor style as Dil Khush contained 375 ml each in which value of (35X35/- = 1225/-) (2) 25 litres ID liquor in 11 plastic bottle (each bottle contained 2 litres) in which value of (25X140= Rs. 3500 /-), under proper seizure list ~~duly~~ signed by the witness and also labeled the same. I seized 01 bottle Dil Khush and I collected 500 ml ID liquor from said ID liquor bottle in a plastic bottle as sample both sealed with gala out of the above.

Under the above circumstances, I pray before you that a specific case may kindly be registered against the arrested accused person namely, Mrinal Bit (36 Yrs) S/O- Bangshi Bit of Katjuridanga, Dinabandhupally, PS & Dist.- Bankura under proper section of Law.
