Sub:- Prayer for lodging FIR against Biswanath Bauri (M/24 yrs) S/O-Banku Bauri of Gopinathpur, Bauripara, PS+Dist- Bankura.

Sir,

In producing here with the arrested person namely Biswanath Bauri (M/24 yrs) S/O-Banku Bauri of Gopinathpur, Bauripara, PS+Dist- Bankura along with seized articles as per seizure list i.e. 1) one Country made one shutter pipe gun length approx 26 cm having iron butt covered with Black tape, firing pin, spring etc with a barrel length approx 16 cm and 2) One round live ammunition of .303, I, SI Chandan Dutta of Bankura PS do hereby lodge a written complaint to the effete that today i.e on 17.02.2024 at about 22:15 hrs received a credible source information that one Biswanath Bauri (M/24 yrs) S/O-Banku Bauri of Gopinathpur, Bauripara, PS+Dist- Bankura was loitering near Kargahir more with fire arms to commit any crime. The matter was diarized vide Bankura P.S GDE No-1041 dt 17.02.2024 and also informed the same to I/C Bankura PS.

Then, as per your order, I, SI Chandan Dutta along with SI Animesh Mahato, C/2672 Dasarath Hembram and HG/35 Mohan Kisku(vide C.C No-739/24 dt 17.02.2024) left PS with our govt. vehicle to work out the information vide Bankura PS GDE No 1042 Dt. 17.02.24. At about 22:40 hrs we reached near Kargahir more under Bankura PS area and kept our vehicle 1 km away from the Kargahir more. Then we moved surreptitiously towards the more. On reaching Kargahir more we found one person was loitering there in a suspicious manner. Seeing us he tried to flee away, but after a hot chase we managed to apprehend the above noted accused person near Kargahir more under Bankura PS area. On being asked he disclosed his identity as noted above and admitted that he had possessed an illegal fire arms. Then we offered him to search us, but he denied to search us. Then I searched that person in presence of passerby witnesses. On search one Country made one shutter pipe gun length approx 26 cm having iron butt covered with Black tape, firing pin, spring etc with a barrel length approx 16 cm loaded with one round live ammunition of .303 was recovered from the left waist of the accused Biswanath Bauri. After that I asked him to produce license of it but he failed and was not even able to give any satisfactory answer. Accordingly, I unloaded the fire arms and seized those articles in proper seizure list in presence of passerby witnesses and duly signed by them & the accused person. Then I arrested the above noted accused for keeping illegal fire arms and ammunition, after observing all the legal formalities of NHRC guidelines and order of Hon'ble Apex Court.

Therefore, I pray before you that one specific case may kindly be started under proper section of Arms Act against the arrested person Biswanath Bauri (M/24 yrs) S/O-Banku Bauri of Gopinathpur, Bauripara, PS+Dist- Bankura and arrange for it's investigation.
