Sub: Complaint against the arrested accused person namely Prakash Lohar, (60 Yrs) S/O – Lt. Sunil Lohar, of Vill-Ekteswar, PS & Dist.- Bankura for lodging FIR against him.

Sir,


In producing herewith, the arrested accused person namely Prakash Lohar, (60 Yrs) S/O – Lt. Sunil Lohar, of Vill-Ekteswar, PS & Dist.- Bankura for along with seized article i.e. 18 litres ID liquor in 09 plastic bottle (each bottle contained 2 litres) in which value of (18X140= Rs. 2520/-), I beg to report that today i.e. on 23.02.2024 at 09:45 hrs, I ASI Subhasish Maity of Bankura PS during my mobile duty received a secret and credible source information that one person was selling ID liquor at a vacate place Ekteswar Shib temple under PS & Dist.- Bankura. Over this source information, I along with force had been to Ekteswar Shib temple at 10:05 hrs to work out the information. I along with force surrounded the PO & found that one person was selling ID liquor beside Shib temple and some persons were purchased ID liquor from him. I along with force held raid, but on seeing Police team all purchaser fled away but we are able to apprehend one person who was selling liquor. I asked him to produce valid license for selling liquor but he failed to produce any valid documents. I asked him about his identity & he disclosed his identity as, Prakash Lohar, (60 Yrs) S/O – Lt. Sunil Lohar, of Vill-Ekteswar, PS & Dist.- Bankura. So, I arrested him at 10:45 hrs after observing all the legal formalities. I explained him about the ground of arrest and I seized 18 litres ID liquor in 09 plastic bottle (each bottle contained 2 litres) in which value of (18X140= Rs. 2520/-) under proper seizure list duly signed by the witnesses and also labeled the same. I collected 500 ml ID liquor from said bottle in a plastic bottle as sample and sealed with gala.

Under the above circumstances, I pray before you that a specific case may kindly be registered against the arrested accused person namely Prakash Lohar, (60 Yrs) S/O – Lt. Sunil Lohar, of Vill-Ekteswar, PS & Dist.- Bankura under proper section of Law.
