Dear Sir,

I Sri, Siddhartha Gupta, S/O Late Paresh Nath Gupta, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint against Sri MURULI GHOSH (user), S/O – Lt HARIPADA GHOSH Vill-Ramchandrapur, P.O- Beliatare, PS- Beliatare Dist- Bankura committed theft of Electricity dishonestly for his paddy thrashing purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

On getting information today 29.01.2024 at about 11:30 AM, I along with 1) Sri RAKESH KABIRAJ, J.E (Gr-II) 2) SATYAPADA ROY, Senior T.S.H all from Beliatare CCC, WBSEDCL inspected the premises at VIII-Ramchandrapur, P.O- Beliatare, PS- Beliatare Dist- Bankura.

During inspection it was detected that Sri MURULI GHOSH (user), S/O – Lt HARIPADA GHOSH committed theft of Electricity dishonestly by means of direct hooking from nearby LTOH line of WBSEDCL for his commercial use (Paddy thrashing) for which WBSEDCL losses huge revenue.

Observed load was found as 0.375 kW.

Inspection report was prepared on spot. Accused person refused to sign in the inspection report & others local public refused to sign.

I directed the technical staff to remove the hooking wire from LTOH line.

I seized some portion of hooking wire with hooking device and extension board and prepared the seizure list.

We left the spot at about 11:45 AM.

The said accused person is liable for prosecution as committed theft of electricity by direct hooking from nearby LTOH line of WBSEDCL which is offence under Section 135 (1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain & treat this letter as F.I.R to start a case for further investigation to stop such revenue loss of WBSEDCL.
