Sub: Prayer for lodging FIR.

Sir,

In producing here with two arrested accused persons namely (1) Ibrahim Mondal S/o- Kached Ali Mondal of vill+PO-Kharampur, PS- Hasnabad, Dist- North 24 Pgs & (2) Sahanur Gazi (22yrs) S/O- Masum Gazi of Kalinagar, Chaltaberia, PS-Hasnabad, North 24 Pgs along with One TATA Motors Goods Carrier Truck bearing Reg No-WB787389, Chassis No-MAT466457K5B18886 loaded with sand after preparing proper seizure list, I ASI Jayanta Das of Bishnupur PS lodged complaint as suo-moto that today on 07.02.24 at about 16.35 hrs during my mobile duty, I received an information that one Truck is carrying sand illegally without any challanis coming from Birai More side towards Joypur Side. Accordingly, myself along with my accompanied force placed naka duty near Gopalpur More on SH-02 (Joypur-Bishnupur Road).

During that period at about 17.05 hrs we found that one Truck bearing Reg no-WB78/7389 is coming from Birai More side towards Joypur Side. On suspicion we proceeded towards the truck & asked to stop the truck. In the truck there was two persons Ibrahim Mondal (Driver) & Sahanur Gazi (Helper). On being asked they informed that they have been carrying sand, without any challan. Accordingly, I have searched the truck & found that the truck is loaded with sand. Thereafter, I asked the driver of the truck to produce valid documents in respect of the loaded sand. But he failed to produce any such valid documents in support of the loaded sand & neither he nor his helper give any satisfactory account in this regard.

Then I arrested them and informed them regarding their ground of arrest and issued memo of arrest after maintaining all legal formalities. So far source information collected it is revealed that these arrested persons used to transport the stolen sand. Thereafter, I have seized the above mentioned truck under proper seizure list from the possession of the driver of the vehicle namely Ibrahim Mondal in between 17.45 hrs & 18.15 hrs.

Under the above circumstances I therefore pray that a Specific Case may kindly be started under proper Section of Law against these two accused persons namely (1) Ibrahim Mondal (24 yrs) S/O- Kached Ali Mondal, Dist-North 24 PGS & (2) Sahanur Gazi (22yrs) S/O-Masum Gazi of Kalinagar, Chaltaberia, PS-Hasnabad, North 24 PGS and arrange for its investigation and oblige.
